 - Conduct information sessions for Kids Helpline team members on the services and resources offered by partner agencies.
 - Stay informed about the latest developments in the mental health and child protection sectors to ensure up-to-date knowledge.

- Develop and implement protocols for efficient and effective cross-agency referrals to better support service users.
