purpose of the position

Responsible for delivering quality supports under the Department of Social Services funded Family Mental Health Support Service (Starfish) including counselling, family-based interventions, case management, therapeutic group work, referral, advocacy and practical support, works to empower and capacity-build children, young people and their families to identify and respond to mental health needs and improve mental health and wellbeing outcomes.

responsibilities

May include, but are not limited to

- Ensure quality services that enhance the lives of children and families by focusing on their strengths and inherent abilities:
 - Ensure services are provided in a manner that is client-centred and family focused, strength based, culturally inclusive and trauma and attachment informed;
 - Ensure services are outcome focused, professional and aligned with child safety and vulnerable adults safeguarding requirements;
 - Create opportunities for change in the lives of children and their families through enhanced psychological, social and emotional health outcomes.
- Identify mental health support needs for children and young people referred into the program and provide appropriate intervention within a case management framework and whole-of-family context:
 - Provide comprehensive needs assessment of clients referred into the program;
 - Provide flexible and responsive outreach, site based or virtual services;

- Engage clients and their families in collaborative goal planning and develop individualised Family Action Plans (FAP's) with each child, young person and their family member
- Provide developmentally appropriate interventions using a range of therapeutic modalities;
- Engage in regular review of services with clients and their families to track progress, ensure appropriateness of chosen intervention/s and continued suitability for service;
- Maintain currency of information in the area/s of child and youth mental health, child developmental, developmental trauma and evidence-based practice;
- Contribute to the development, delivery and review of therapeutic group workshops.
- Work collaboratively with internal and external stakeholders to achieve positive outcomes for clients:
 - Maintain knowledge of local networks and organisations within the service region;
 - Engage internal and external services to ensure holistic wrap-around support for clients;
 - Participate in collaborative case planning and stakeholder meetings for clients and families engaged with multiple services;
 - Facilitate referrals to internal support and/or external specialist services as required, for example, specialist counselling;
 - In collaboration with the Coordinator/ Moreton Community Engagement Practitioner, participate in community events, networking and information sessions.
- Ensure quality record management and compliance processes while working within contractual and organisational policies, procedures and frameworks:
 - Ensure activities including actioning of new referrals/allocations, case noting and administration of outcome measures, including, but not limited to, DSS mandated Circumstance SCORE, Goal SCORE and Satisfaction survey, are delivered within specified timeframes;
 - Maintain an active caseload of clients;
 - Ensure services are delivered in line with contractual and operational guidelines;
 - Develop and maintain client records, internal and external data collection and contribute to service evaluation;
 - Provide reports for internal and external agencies as required;
 - Actively participate in team meetings, case reviews, group supervision and professional development as required.
- Participate in and meet the requirements for Practice Supervision and Client Skills Training
- Demonstrate an understanding of and meet the requirements of the position and all performance expectations including:
 - Maintaining currency of knowledge with regards to relevant legislation, professional practice and emerging trends to ensure advice is current and effective
 - Participating in other duties and cross-functional teams as may be required, in order to achieve efficient and effective **yourtown** services

- Participating in and meeting the expectations as agreed pursuant to the Organisational Performance System processes
- From time to time assist in other locations and travel intrastate, or interstate, as required.

Essential knowledge, skills, abilities:

- Relevant bachelor's degree in psychology, Counselling, Social Work or other therapeutic profession with a minimum of 3 years' experience providing therapeutic supports to children, young people and families;
- Demonstrated high level of commitment to the principles of client-centred practice and professional ethical standards underpinned by strengths-based, trauma-attachment and systemic frameworks;
- Demonstrated commitment to evidence-based clinical practice and knowledge of counselling, psychological therapies and case management frameworks;
- Demonstrated skills in needs assessment, case formulation and planning, therapeutic interventions, case management and review.;
- Demonstrated skills in working with children, young people and families from diverse backgrounds;
- Demonstrated high level communication skills, including written skills and the ability to prepare and contribute to reports;
- Knowledge and understanding of relevant ethical standards and legislation e.g. Child Protection, Domestic and Family Violence, Mental Health.

Desirable knowledge, skills, abilities:

- Experience in the development and delivery of therapeutic group work
- Eligibility for professional registration with a member or supervisory body i.e. Australian Counselling Association (ACA), Psychotherapy and Counselling Federation of Australia (PACFA), Australian Association of Social Workers (AASW) or other as relevant;
