- Deploy software applications into the various development and testing environments using agreed CI/CD processes and practices.
- Develop and maintain appropriate automated tests.



- Create and maintain documentation as required to ensure ongoing supportability.
- Work in an agile environment, delivering incremental product functionality in short iterations.
- Estimating and planning to assist with the development of the product roadmap.
- Proactive involvement in research and development of potential new technologies/features to incorporate in the solutions.
- This position involves participation in rostered on-call responsibilities

 - Maintaining currency of knowledge with regards to relevant legislation, professional practice and emerging trends to ensure advice is current and effective.
