### **ABOUT THE ROLE**

### **Role Purpose**

This role is responsible for the delivery of art therapy programs within the Leisure and Wellness programs to vulnerable elderly people in residential aged care.

The Art Programs Officer lives and breathes Uniting's person-centred care approach which aims to celebrate our clients as unique individuals. Working alongside the Leisure and Wellness team, clients' unique physical, psychological, social and spiritual wellbeing is enhanced through meaningful art therapy classes and activities.

## **ROLE KEY ACCOUNTABILITIES**

### Financial management:

- Support positive client outcomes with the delivery of art therapy programs in a cost-effective and timely manner
- Monitor equipment and supplies, and re-order as necessary, in line with relevant budgets

## Operational processes:

- Support the Leisure and Wellness team to facilitate client's leisure and wellness needs
- Work within relevant government legislation and Uniting policies and guidelines



- Handle queries and complaints from our clients and their families, as well as your co-workers and other service providers, in a confidential and timely manner, in collaboration with your supervisor
- Record information accurately and timely in our electronic management systems
- Carry out administrative tasks relevant to the role
- Monitor equipment to ensure safe working order and request maintenance and repairs when needed

### Client management:

- In collaboration with the Leisure and Wellness team, work with our clients to help them set and achieve their goals
- Build rapport with our clients and their families, encourage clients to explore their creative interests and participate in the community
- Ensure a duty of care to clients, whilst respecting their choice and enabling independence and self-determination
- Contribute to the assessment and monitoring of client health and wellbeing outcomes and review art therapy programs to meet individual needs
- Clients, carers and families can be confident that you'll take on board their feedback, leading to an improved customer experience for everyone in the service.
- Your genuine interest in our clients will help you monitor their progress and you'll report any changes or concerns to your supervisor

### As the Art Programs Officer, your role specifically will include:

- Planning, developing and delivering a range of innovative high-quality art therapy programs and activities that support positive health and wellbeing outcomes in clients, which include:
  - Create opportunities for meaningful activity, creativity self-expression and sensory stimulation
  - Support clients with maintaining past interests and hobbies
  - Encourage socialisation and positive group interaction



- Build self-esteem, enabling self-exploration and release of inhibitions
- Nurture spirituality, promote relaxation, reduce agitation and boredom, and encourage reminiscence
- Adapting art therapy activities to accommodate the needs of client groups with different preferences, physical and cognitive abilities
- Using different mediums, including poetry, storytelling, aphorisms, visual arts, and various techniques, as well as age-appropriate concepts
- Managing end-to-end logistics of art therapy activities, including sourcing supplies and equipment, coordinating set-up and clean-up, helping clients with attending the activity; where possible, encouraging clients to participate in set-up and clean-up
- Aligning art therapy programs and activities with Uniting Seniors projects and initiatives (e.g. decorations for specific events, art exhibits, annual Christmas card competition) in collaboration with the Leisure and Wellness team and display art works in designated areas as directed by management
- Building relationships with external providers and local community groups and individuals, and identifying potential partnership opportunities that support meaningful art therapy experiences for clients in the local community
- Identifying and applying for funding opportunities available to aged care service providers and related to art therapy
- Regularly reviewing program content and delivery to ensure that art therapy activities meet client needs and outcomes
