Primary Purpose

To provide high level strategic and operational leadership on identified projects and change management in the Senior Secondary Sector, using relevant information systems and a contemporary approach. Provide advice to the Executive Director that enables the implementation of key initiatives including the future of schooling.

Level of Responsibility/Direction and Supervision

As a Program Manager for Senior Secondary Initiatives, you will lead and manage strategic projects to enhance senior secondary education, overseeing change management processes to ensure smooth transitions. Utilizing information systems, you will track progress, analyse data, and inform decision-making. Collaborating with stakeholders, you will gather insights and ensure alignment with educational goals. Additionally, you will provide expert advice to the Executive Director on implementing key initiatives and monitor and evaluate program effectiveness, making recommendations for continuous improvement.

The Department has a range of delegations in operational areas including Finance, Human Resources and Facilities. The occupant is responsible for ascertaining the delegations that are assigned to these duties and is expected to exercise any applicable delegations prudently and in accordance with any specified limitations.

In the delivery of the department's activities, the occupant must ensure that:

- Within the occupant's area of organisational responsibility, appropriate strategies are in place to minimise the risk of fraud; and
- Decisions and actions are made ethically and with integrity, on the basis that such is legal, is right and is reasonable based on an objective standard.

Primary Duties

1. Co-ordinate a strategic and responsive approach to program design, implementation and change management processes for the future of Senior Secondary education, including the oversight of project teams and their performance in meeting short and long term goals.
2. Develop and maintain comprehensive project plans, incorporating strategies, timeframes, risk assessments and reporting stages.
3. Provide high level support, advice and recommendations regarding required processes, documentation and communications to deliver project outcomes.
4. Collaborate with relevant partners and stakeholders and establish effective networks with key stakeholders to ensure the alignment of work and ensure knowledge, issues and views of all key groups are given appropriate consideration.
5. Analyse information and data and provide advice, regular reports and recommendations to inform the Executive Director.
6. Undertake strategic projects and develop and coordinate the Executive Director's internal and external stakeholder engagement framework.
7. The incumbent can expect to be allocated duties, not specifically mentioned in this document, that are within the capacity, qualifications and experience normally expected from persons occupying positions at this classification level.

Selection Criteria

Employment in the State Service is governed by the *State Service Act 2000* and employment decisions must be based on merit. A decision relating to appointment or promotion is based on merit if:

- an assessment is made of the relative suitability of the candidates for the duties; and
- the assessment is based on the relationship between the candidates' work-related qualities and the work-related qualities genuinely required for the performance of the duties; and

- the assessment focuses on the relative capacity of the candidates to achieve outcomes related to the duties; and
- the assessment is the primary consideration in making the decision.

Work-related qualities might include; skills and abilities; qualifications, training and competencies; standard of work performance; capacity to produce required outcomes; relevant personal qualities; and demonstrated potential for future development.

The following specific selection criteria must be addressed by candidates. The nominated position objective and duties contained in this statement of duties must also be used to assist in the interpretation of these selection criteria.

1. Demonstrated knowledge and experience in the planning, management and delivery of strategic programs and contemporary project management practices, policy development and change management in a Government environment.
2. Demonstrated high level project management skills including the ability to supervise staff, work independently, manage competing priorities and delivery high quality outcomes to strict deadlines.
3. Highly developed management and leadership skills coupled with the sound knowledge of contemporary management principles including managing a client focused environment and managing external clients and consultants.
4. Demonstrated high level interpersonal skills with the ability to communicate with influence, negotiate persuasively, resolve conflict, develop effective networks, and facilitate meetings in order to contribute to the achievement of organisational outcomes.
5. High level of initiative and flexibility, with demonstrated capacity to plan, organise, schedule, and deliver project outputs and to modify approaches and adapt to change requests throughout a project lifecycle.
6. A demonstrated commitment to working in a values-based organisation with the ability to support the development of team members and to seek and provide constructive feedback.

Requirements

Registration/licences that are essential requirements of this role must remain current and valid at all times by the occupant who is assigned these duties. The status of these essential requirements may be checked at any time during employment. It is the employee's responsibility to ensure that registration/licences remain current and to advise the Department if their circumstances change. This includes notifying the Department of any new criminal charges or convictions and/or if a registration/licence is revoked, cancelled or has its conditions altered.

Essential

- The *Registration to Work with Vulnerable People Act 2013* requires persons undertaking work in a regulated activity to be registered. A regulated activity is a child related service or activity defined in the *Registration to Work with Vulnerable People Regulations 2014*. This registration must remain current and valid at all times whilst employed in this role and the status of this may be checked at any time during employment.
