Context

The registration and monitoring of home education in Tasmania is overseen by the Office of the Education Registrar. The Registrar works closely with home educators to make home education a strong, valued part of our education system.

Primary Purpose

Under the day-to-day guidance and supervision of the Manager of the OER, undertake various administrative and clerical duties which support the function of the team and its business operations. This will include the provision of a client focused reception service and assisting with operational processes, including the maintenance of databases and related matters.

Level of Responsibility/Direction and Supervision

The occupant directly responsible for the efficient and accurate completion of assigned duties and the achievement of set outcomes. The occupant must be able to exercise some discretion subject to business requirements.

The occupant operates under routine supervision and general guidance and is expected to use initiative. Overall direction is provided by the immediate supervisor.

It is the responsibility of the occupant to actively participate, promote and model behaviours which are consistent with the Department's commitment to the safety and wellbeing of children and young people. This includes the prevention, identification and reporting of child abuse and behaviours which are not consistent with the Department's values.

The occupant is responsible for complying with all Agency policies and procedures, including those relating to fraud and corruption control, record management, confidentiality, conduct and behaviour, mandatory reporting, education, training and assessment.

The Department has a range of delegations across the operational portfolio's which include Finance, People Services and Support (HR) and Facilities. The occupant is responsible for ascertaining the delegations that are assigned to these duties and is expected to exercise any applicable delegations prudently and in accordance with a range of Acts, Regulations, Awards, administrative authorities and functional arrangements.

Primary Duties

1. Process documentation relating to home education applications including database management, receipt and acknowledgement of applications, preparation of correspondence, follow-up of receipt, and the processing of provisional approvals.
2. Assist with the management of bookings for Registration Officer visits and prepare and provide information to families and Registration Officers.
3. Complete a range of multiple and diverse administrative tasks to support the day-to-day operations of the Home Education unit including meeting arrangements, ordering office supplies, filing, mailing and drafting basic correspondence.
4. Provide administrative assistance to staff, managers and stakeholders, and handle basic telephone and face-to-face enquiries from the public.
5. Use a wide range of computer software or systems and other general equipment to produce a variety of documents.

6. The incumbent can expect to be allocated duties, not specifically mentioned in this document, that are within the capacity, qualifications and experience normally expected from persons occupying positions at this classification level.
7. In accordance with the *Work Health and Safety Act 2012* the incumbent will actively participate in and contribute to the maintenance of safe working conditions and practices, including the development and implementation of improvement initiatives, safeguarding practices and all mandatory training requirements.

Selection Criteria

The following specific selection criteria must be addressed by candidates. The nominated position objective and duties contained in this statement of duties must also be used to assist in the interpretation of these selection criteria.

1. Proven administrative and organisational skills and a capacity to work with flexibility and act independently within established guidelines, using initiative, discretion and sound judgement.
2. Good communication and interpersonal skills including the ability to liaise effectively with stakeholders and staff at all levels in a sensitive and confidential manner.
3. Demonstrated experience in the efficient and effective use of current office technologies (including MS Office or similar programs) and the ability to adapt to new technology and procedures as required.
4. Good written skills with the ability to prepare correspondence and documents which are clear, concise and accurate.
5. Proven ability to work as an individual and as a member of a team, together with the ability to undertake work within set time-frames.
6. A demonstrated capacity to commit to the Department's values, with the ability to apply them through individual behaviours and actions.

Requirements

Registration/licences that are essential requirements of this role must remain current and valid at all times whilst employed and the status of these may be checked at any time during employment. It is the employee's responsibility to advise the Department if there is any change to the status of a registration/licence. This includes notifying the Department of any new criminal charges or convictions and/or if a registration/licence is revoked, cancelled or has conditions applied.
