The Technology group is currently delivering a multi-year Technology Refresh program which involves the commissioning of new systems and capability to support a contemporary DHA service offering. The Application Development and Integration Team's role is to contribute to this work as part of Multi-Disciplinary Teams (MDT's) to analyse, develop, test and integrate both new and existing software. In addition, the team supports the software remediate program ensuring existing technologies are current, bug free and align with security requirements.

YOUR CONTRIBUTION

As the Director, Application Development and Integration, your role will be to provide technical leadership and direction to the Software Development, Data Provisioning and Testing teams. You will also work collaboratively with the Architecture and IT Operations Groups considering dependencies and impacts in the context of modernisation programs and application support.

Working with technologies including Java, .NET, Jira, Salesforce, Mulesoft, Azure DevOps, Oracle BI and Tableau, you will play a pivotal role in ensuring the technical development environment roadmap is fit for purpose in the context of DHA's strategic priorities. The Director will contribute technical expertise as part of the Architecture Board, the Technology Prioritisation Committee and lead decisions with respect to the implementation and sustainment of new technologies and sustainment of legacy systems. In addition, you will hold responsibility for ensuring continuity of appropriate technical skills across the team through the Technology Group's strategic workforce plan in the context of both the current and future programs.

As part of this role your responsibilities will include:

- 1. Lead and mentor the application development, integration, and testing teams for following best practices and continuous innovation of building and delivering business solutions with DHA's technology platforms while ensuring the quality of solutions meet business needs.
- 2. Set the technical direction, provide leadership and apply your own subject matter expertise to deliver and support fit-for-purpose technical solutions into production environments. This includes ownership of the technical roadmap, incorporating Architectural Strategies and Transitional State of DHA Systems. Identify the dependencies on Infrastructure, Cloud and Cyber Security capabilities that are required to deliver the technical roadmap.
- 3. Be an active member of architectural forums and contribute to the architectural direction of the organisation via collaboration within BS&T Group.
- 4. Ensuring adherence to security and compliance standards within the DHA's software development lifecycle process including coding standards, best practices, and quality assurance processes.
- 5. Collaborate with stakeholders to prioritise work activities, resource allocation, and skill alignment as part of MDTs. Prioritise the resolution of system issues and incidents in a timely manner to maintain and support business function continuity.
- 6. Prioritise systems changes and enhancements to existing systems as part of monthly release cycle that support Technology Refresh deliverables and ensure to have rigorous regression tests to ensure critical business outputs are maintained with expected accuracy.
- 7. Build productive relationships across the organisation and with partners. In this role, your ability to lead and influence will hold equal importance with your technical subject matter expertise.
- 8. Drive team productivity, efficiency, collaboration and communication within the team and cross-functional teams, ensuring alignment of goals and promoting knowledge sharing.
- 9. Invest in the appropriate resourcing and development of the applications development and integration team including actively mentoring and coaching on best practice approaches, fostering a culture of continuous improvement and professional growth.
