The Data Engineer plays a key role in enabling data-driven decision-making across the organisation by developing integrations, optimising data workflows, and collaborating with the Senior Data Engineer to rationalise the data warehouse. They are also responsible for continuously improving data processes, working closely with the Data & Analytics team to meet project timelines and deliver high-quality data solutions.

- Documentation & Communication: Ensure that all changes, enhancements, and rationalisation efforts in the data
 warehouse are clearly documented and communicated to both the Data & Analytics team and other relevant
 stakeholders.
- Stay current with emerging technologies and methodologies in cloud data platforms, integration, and data engineering.
- Drive continuous improvements by optimising existing data processes and proposing innovative solutions to enhance data workflows and infrastructure.
