Our Organisation

Catholic Education Sandhurst Limited (CES Ltd) is committed to the mission of Catholic Education across the Diocese of Sandhurst. With a rich history dating back to 1853 the Diocese reaches from Central to Northeast Victoria. The organisation supports more than 3000 employees in 52 schools and 3 early childhood facilities. It also provides support to 4 secondary colleges owned and operated by Religious Institutes.

CES Ltd participates and cooperates in the work of the Victorian Catholic Education Authority (VCEA), which has key responsibilities for the allocation and distribution of government funding, facilitating cooperation across the four Victorian Dioceses, and in working and cooperating with government statutory authorities.

The Executive Director of Catholic Education Sandhurst is appointed by the Board of CES Ltd to support the administrative, organisational, and service matters to Catholic schools within the Diocese.

The Executive Director and all delegations via that position operate within the parameters of Canon Law and the Catholic Church structures and processes. CES Ltd is the employing authority for its schools and acknowledges and respects the role of Parish Priests within the Parish communities in which schools are located and supported.

Our Vision

The vision for CES Ltd is to provide, in partnership with our families and parishes, stimulating, enriching, liberating, sacramental and nurturing learning environments drawn from the Catholic tradition in each of the diocesan school communities.

Position Summary



Leadership Framework

Key Responsibilities

	 Promote and communicate current and future Arts curriculum programs to students and families through Course Handbooks and other means.
Strategic resource planning and	Manage, review and maintain relevant curriculum budgets, including resource requests for consumables.
compliance	 Investigate and propose capital purchases for contemporary learning across relevant learning areas.
	 With the Curriculum Team, develop, review and implement the booklist considering the need for student resources in balance with the financial burden on families.
	 Liaise with the Deputy Principal - Community, Culture and Engagement to ensure that all equipment and resources are fit for purpose.

Leading Learning and Teaching

- Develop assessment practices that focus on student growth and development, providing effective and continuous feedback for students.
- Ensure consistency in application of the VCAA curriculum and assessment across the learning area
- Support the application of pedagogies that ensure active engagement in authentic, purposeful learning that capitalise on, and meet, the diverse needs of all students.
- Assist in reviewing the curriculum and pedagogy to ensure a consistently high-quality environment for learning.
- Ensure interventions are in place to reduce gaps in attainment, communicating high aspirations and expectations for all, celebrate success and challenge underperformance.
- Model collaborative leadership and engage with other schools and organisations to share and improve practice and encourage innovation.
- Promote and model a culture of continuous improvement, ensuring research, innovation and creativity are core characteristics of the school.
- Support and lead applicable CES Ltd learning and teaching initiatives.
- Support the development of Professional Learning Communities within our college.

- Depending on the role some employees will be required to provide evidence of successful completion of First Aid Certificate inclusive of Anaphylaxis training prior to commencing employment with CES Ltd.
