

### **Key Duties/Responsibilities**

#### 1. PROFESSIONAL/CLINICAL

- 1.1. Provides psychiatric care and general treatment in both inpatient and outpatient facilities for children aged between 0-18 years of age and their families of the Great Southern Mental Health Service.
- 1.2. Provides clinical leadership and supervision of clinical care within the CAMHS across the region.
- 1.3. Provides supervision for community care including community treatment orders.
- 1.4. Provides governance and clinical management of the CAMHS treating team.
- 1.5. Acts for the Clinical Director in his/her absence, as required.
- 1.6. Participates in an on-call roster.
- 1.7. Supervises trainee psychiatrists and medical officers and participates in the teaching of other health professionals.
- 1.8. Travels within the Great Southern region as required.
- 1.9. Liaises and confers regularly with general practitioners, other health care professionals and agencies on clinical matters and treatment programs.
- 1.10. Attends to statutory requirements under the Mental Health Act 2014.
