Regional Overview

The Goldfields region of the WA Country Health Service covers the Goldfields-Esperance Region of Western Australia. The region is located in the south eastern corner of Western Australia and covers 770,488 sq km (including offshore islands). The WA Country Health Service Goldfields consists of two main health campuses located in Kalgoorlie & Esperance, and three smaller hospitals located in Laverton, Leonora and Norseman. The Goldfields is a culturally rich region with a number of Aboriginal communities spread out across the region, 16 distinct Aboriginal language groups and an Aboriginal population that represents 12.3 per cent of our total population, with 1 in 10 people, on average, identifying as Aboriginal – this in comparison to the state average of 3.6 per cent. The region supports a wide range of industry, including mining, agriculture, aquaculture and tourism. Mining is the predominant sector in the central and northern parts of the region, with a well-established agricultural sector in the south.

Key Duties/Responsibilities

1. CLINICAL LEADERSHIP

- 1.1. Responsible for specialist clinical care of Obstetric and Gynaecological patients attending Kalgoorlie Health Campus and across the region including Esperance.
- 1.2. Manages Obstetric/Gynaecological conditions according to acceptable clinical standards.
- 1.3. Collaborates with Maternity Ward Clinical Nurse Specialist and Nursing staff to facilitate patient management. Liaises with patients, family, community services and other representatives as required to facilitate patient management.
- 1.4. Supervises, mentors and educates candidates for the diploma of Obstetrics and any trainee medical staff and hospital service medical practitioners who are providing clinical care to Obstetric or Gynaecological patients.
- 1.5. Liaises with other senior medical staff in Kalgoorlie and regionally, with allied health staff and with hospital managers to facilitate a high standard of patient care. Negotiates with patient transport providers such as the Royal Flying Doctor Service and St John Ambulance to facilitate transfer of patients for tertiary care.
- 1.6. Promotes clinical governance and clinical risk management within the Obstetric and Gynaecological Department.
- 1.7. Maintains and updates professional knowledge. Participates in research where appropriate. Trains and supervises medical students as appropriate.

2. ADMINISTRATIVE LEADERSHIP

- 2.1. In collaboration with other General Practitioner and Specialist Obstetricians and the Midwifery and Surgical nursing staff, actively participates in the management of the Midwifery Medical Department including equipment choice, staffing proposals and workplace redesign. Undertakes performance management of subordinate staff.
- 2.2. Participates in clinical policy development and review.
- 2.3. Participates in data collection, clinical audit and other Quality Assurance Program activities.
- 2.4. Participates in relevant hospital, regional and state committees as required.
- 2.5. Prepares medical reports.
- 2.6. Undertakes strategic planning in conjunction with hospital and regional management.
