#### **Key Duties/Accountabilities**

- 1. Assist clients to participate in a variety of therapeutic programs under the direction of allied health professionals. This includes effectively administering therapeutic group programs (large and small), assist in comfortable positioning, delivering prescribed individual therapy interventions and facilitating community access.
- 2. Support clients in meaningful, purposeful activities based on what is important to the client by knowing what the client is interested in.
- 3. Ensure all allied health activities are provided in a personalised manner to the client in accordance with the client's care plan, and adhere to relevant policies of Brightwater, appropriate professional Code of Ethics, and to relevant legislation affecting professional practice and other relevant standards and guidelines.
- 4. Gather objective and subjective client information and provide feedback to relevant allied health professionals and other staff on the client's wellbeing, function and progress, and document observations to the required standard.
- 5. Contribute to the evaluation of the effectiveness of service delivered to clients, complete Brightwater documentation to the required standard and report and/or escalate incidents and issues in line with Brightwater's expectations.
- 6. Communicate with clients, client representatives, colleagues and community in a professional manner that shows respect for individuals.
- 7. Carry out administrative and non-clinical tasks to support the allied health consultancy service and clients under the direction and delegation of allied health professionals.
- 8. Provide services in a responsible, cost effective and efficient manner with an awareness of the appropriate use of supplies. This includes supporting the ACFI process (residential aged care only).
- 9. Actively collaborate with the rest of the multidisciplinary team and regularly plan and review the therapy programs of clients, making changes to ensure the program is individualised and meaningful to clients and in line with their needs and preferences, as approved by the relevant allied health professionals.
- 10. Implement delegated tasks from relevant allied health professionals, within scope of position. Participate in regular supervision and development with allied health professionals around workflow, knowledge, and clinical practice to ensure competence to deliver on delegations.
