Primary Purpose:

In accordance with hospital policies, procedures and statutory regulations the Staff Specialist - Hyperbaric Medicine will:

- Provide clinical services of the highest possible standard to hyperbaric medicine patients.
- Actively pursue improved outcomes for hyperbaric medicine patients by participating in teaching and research relevant to hyperbaric medicine.

Duties:

1. Provide services in hyperbaric medicine including diagnosis, treatment and care for patients, both inpatient and outpatient, at the Royal Hobart Hospital, and where appropriate, other hospitals across Tasmania.
2. In consultation with other clinical services, assist with the management of Royal Hobart Hospital patients.
3. Participate in undergraduate and postgraduate teaching programs.
4. Undertake research in hyperbaric medicine.
5. Participate in hospital committee and administrative matters as required by the Chief Executive Hospitals South, the Clinical Director for Surgical and Perioperative Services and/or the Director - Hyperbaric Medicine.
6. Actively participate in and contribute to the organisation's Quality & Safety and Work Health & Safety processes, including in the development and implementation of safety systems, improvement initiatives, safeguarding practices for vulnerable people, and related training.
7. The incumbent can expect to be allocated duties, not specifically mentioned in this document, that are within the capacity, qualifications and experience normally expected from persons occupying positions at this classification level.

Key Accountabilities and Responsibilities:

The occupant of the position will work under the broad direction of the Director - Hyperbaric Medicine and will be responsible for working in accordance with the following performance criteria:

- Provide high-quality service under the direction of the Clinical Director for Surgical and Perioperative Services and the Director - Hyperbaric Medicine to patients of the Royal Hobart Hospital (RHH) by:
 - Providing appropriate clinical care to patients.
 - Coordinating the follow-up care of patients.
 - Attending inpatients rounds and consulting clinics as scheduled.
 - Contributing to an after-hours on-call service in accordance with a roster.
 - Ensuring effective communication with care-providers, especially General Practitioners, to promote continuity of patient care.
- Demonstrate a commitment to continuous service improvement by:
 - Participating in the development of clinical guidelines and protocols.
 - Attending and participating in clinical and departmental meetings.

- Participating in departmental peer review and audit activities.
- Continuously reviewing existing practices and promoting change where required.
- Participating in Risk Management and Quality Improvement programs undertaken by the RHH.
- Participating in college-based programs directed towards maintaining the highest standards of professional care.
- Participating in personal performance appraisal.
- Demonstrate a commitment for personal and professional development by:
 - Attending conferences to maintain and enhance knowledge.
 - Participating in programs designed to provide personal growth and development.
- Demonstrate a commitment to the provision of a multidisciplinary approach to clinical care by:
 - Working harmoniously with all members of the clinical team.
 - Being responsive to the expectations and needs of both clinical and non-clinical colleagues.
- Engender a consumer focus in service delivery by:
 - Ensuring consumers are able to exercise their rights and responsibilities.
 - Ensuring that patients and families are given adequate information upon which to base treatment decisions and follow up.
 - Being responsive to complaints from patients and their relatives.
 - Demonstrating empathy for patients and their families.
- Provide appropriate support, direction and training to trainee medical officers, nurses and medical students in liaison with the Professor of Surgery, University of Tasmania by:
 - Providing appropriate direction and supervision to Registrars, Resident Medical Officers and Interns.
 - Acting as a role model and mentor for trainee medical staff, nurses and medical students.
 - Participating in the education of trainee medical staff, nurses and medical students.
- Participate in and contribute to academic life of the Department by:
 - Conducting research.
 - Participating actively in postgraduate educational activities eg: Grand Rounds.
 - Contributing to the supervision of postgraduate students.
- Promote and contribute to the maintenance of a safe working environment by:
 - Complying with occupational health, safety and welfare policies and other written arrangements for occupational health, safety and welfare at work.
 - Participating in relevant occupational health, safety and welfare programs.
 - Complying with any reasonable instruction and following safe-work practices in relation to occupational health, safety and welfare at work.
 - Participating in training programs and on the job training programs for health, safety and welfare.

- Reporting all incidents, accidents and observed hazards to their supervisor or manager as soon as possible and assisting in the investigation process.
- Supporting the role of the health and safety representatives by keeping them informed of any issues relating to health, safety and welfare in the workplace.
- Ensuring that you are not, by the consumption of alcohol or a drug, in such a state as to endanger their own health, safety at work or the health and safety of any other person.
- Participating in appraisals to evaluate Work Health & Safety (WH&S) performance.
- Champion a child safe culture that upholds the *National Principles for Child Safe Organisations*. The Department is committed to the safety, wellbeing, and empowerment of all children and young people, and expect all employees to actively participate in and contribute to our rights-based approach to care, including meeting all mandatory reporting obligations.

Pre-employment Conditions:

It is the Employee's responsibility to notify an Employer of any new criminal convictions during the course of their employment with the Department.

Selection Criteria:

1. Demonstrated ability to manage patients within the discipline of Hyperbaric and Diving Medicine with appropriate postgraduate sub-specialty qualifications in Diving and Hyperbaric Medicine, or actively working towards qualifications, together with clinical experience in a tertiary hospital department of Diving and Hyperbaric Medicine.
2. Experience in providing inpatient and outpatient care, including having the medical fitness to dive/work under pressure in accordance with AS/NZS 4774.2:2019 - Work in compressed air and hyperbaric facilities Part 2: Hyperbaric Oxygen facilities.

3. Ability to work within a multidisciplinary team of medical, nursing, and health professional staff.
4. Demonstrated capacity for undergraduate and postgraduate teaching, together with the ability to undertake and manage research activities.
5. Demonstrated ability to communicate effectively and maintain good interpersonal relationships in dealing with patients, their relatives and professional colleagues.
6. Knowledge of continuous quality improvement activities relevant to practice within the clinical discipline.
7. Evidence of ongoing participation and commitment to continuing medical education.
8. Demonstrated ability to function in an administrative capacity within a hospital department.
