- Support the Workshop Manager with workshop requirements including, but not limited to, the maintenance of machinery, security access, and bookings to support effective use of the facilities.
- Establish clear and effective protocols and processes to support the operationalisation of new research and teaching and learning facilities.
- Provide design support to workshop services team during the production process to ensure manufacturing efficiency, safety and product quality.
- Support teaching and research users to access workshop services.
