Position Summary

The School of Geography, Earth and Atmospheric Sciences is searching for an outstanding academic to fill a new teaching and research position in health geography. We are seeking someone with a commitment to empirical research in place, and who applies geographical (and/or a closely-related discipline) concepts and methods to the study of health, wellbeing, disease, and healthcare. Areas of research and teaching focus would broadly focus on the relationships between place and human health, but might range from health inequalities, to environmental and planetary health, to social determinants of health.

The successful applicant would join a vibrant teaching and research culture in the School, which embraces its key disciplines as well as the multi-disciplinary synergies across the School and Faculty. The appointee would contribute to teaching excellence, primarily in the geography program, at both undergraduate and postgraduate levels, as well as potentially contributing to multi-disciplinary subject areas. They will also make significant contributions to research, developing their own research agenda that has impact on academic knowledge and the broader community.

The School of Geography, Earth and Atmospheric Sciences combines discipline strength and expertise in those three areas, from the social sciences through to the quantitative physical sciences. In addition to our internationally recognised discipline expertise, we have strength in several multidisciplinary thematic areas including: climate change; resource futures; space, place and social change; environmental hazards; Indigenous knowledge; and Earth system interactions. The successful applicant will have teaching and research interests that sit within the discipline of geography, intersecting with one or more of these multidisciplinary themes.

We encourage applicants from under-represented groups, including Aboriginal and Torres Strait Islander people. To allow us to consider performance relative to opportunity, we also invite applicants to provide a brief statement (up to 1 page) that describes circumstances that may have affected their career development or progression, including career interruptions or delays, periods of part time work, or forms of bias they have experienced.

1. Key Responsibilities

As with all positions, career achievements will be interpreted relative to opportunity, including career disruptions due to caring responsibilities, time in industry, illness etc.

A Lecturer (Level B) is expected to make contributions to the teaching effort of the institution and to carry out activities to maintain and develop their scholarly, research, and/or professional activities relevant to the profession or discipline.

Specific duties:

1.1 TEACHING & LEARNING

The appointee will be expected to:

- Contribute to the undergraduate and graduate curriculum in health and human geography that complements and builds on the existing strengths of the School
- Prepare and deliver lectures, tutorials and seminars as appropriate and in line with Faculty of Science minimum thresholds for teaching satisfaction
- Provide academic mentoring and assistance to students
- Coordinate, lead or participate in student field trips
- Undertake administrative tasks associated with subjects taught, including consultation with students, marking and assessment
- Undertake subject coordination including the supervision of sessional tutors
- Supervise honours students and postgraduate coursework and research higher degree students, as required, and will be expected to ensure timely completion of their research.

1.2 RESEARCH

The appointee will be expected to:

- In collaboration with Senior Academic staff, conduct internationally competitive research in human and health geography, resulting in publications in high impact journals
- Contribute to and publish academic papers and other scholarly outputs to a high academic standard in accordance with the research expectations of the University of Melbourne
- Contribute to the preparation, or where appropriate individual preparation of research proposal submissions to internal or external funding bodies as relevant.
- Active participation in research seminars, and national and international conferences
- Contribute to developing networks within the discipline and with other universities, institutions and communities, both nationally and internationally, to support collaboration.
- Present research to the public to elevate public awareness of educational and scientific developments and promote critical enquiry and public debate within the community.
- Undertake administrative functions and obligations primarily connected with the staff member's area of research

1.3 LEADERSHIP AND SERVICE

The appointee will be expected to:

- Contribute to a range of administrative functions, including those connected with their research activities, teaching responsibilities and the administration and governance of the School and / or Faculty of Science.
- Actively participate at School meetings and contribute to planning activities or committee work to support capacity building in the School/discipline.
- Demonstrate involvement in professional activity in the discipline and/or multiple disciplines.
- Contribute to School activities such as Open day to promote student engagement
- Effectively demonstrate and promote University values including diversity and inclusion and high standards of ethics and integrity

2. Selection Criteria

2.1 ESSENTIAL

- A PhD in geography or a closely related discipline.
- An emerging track record of publications in one or more aspects of health geography in leading international journals or other high-quality publications, relative to career opportunity.
- Research expertise in health geography that demonstrates a commitment to empirical research in place.
- An emerging capacity to establish collaborations and engage with a broad range of researchers nationally and internationally.
- Evidence of ability to participate in applications for external research funding from national competitive research bodies or other sources, which may include industry, government, community groups, etc.
- Evidence of the ability to teach broadly into an undergraduate and/or graduate geography program including a capacity to contribute to teaching in Health Geography.
- Evidence of a commitment to engage respectfully with diverse communities, including Indigenous communities, and culturally aware teaching and research.
- A demonstrated capacity to supervise undergraduate and graduate research students.
- A potential or demonstrated capacity to initiate or contribute to service activities within the School, the Faculty of Science, and the broader professional community.
- Excellent oral and written communication skills in English.
- Interpersonal and organisational skills including the ability to project manage, meet deadlines, and interact with colleagues from a broad range of disciplines in a collegial, respectful and effective manner.

2.2 DESIRABLE

A potential or demonstrated capacity to conduct research activities in collaboration with community groups, industry and/or government.
