## **Key Accountabilities**

- Under the general direction of the ABC iview Content Manger this role is accountable for the
  presentation of all English and multi-language content on the ABC Australia iview app, owned
  and third-party EPGs, and for supporting the day-to-day smooth running of the ABC iview Editorial
  team.
- Ensure that, at all times, the program assets, images, text, collections and all other content reflect pre-determined network plans and priorities, and are presented in a way which is timely, relevant, compelling and accurate.
- Timely distribution of ABC NEWS channel program guide, and enactment of program amendments affecting content in ABC Australia iview and EPGs.
- Provide pro-active assistance and support to the ABC iview Content Manager by playing an
  active role in sourcing content for digital availability, and by fostering positive and productive
  relationships with internal and external stakeholders.
- Produce short-term publishing and curation plans for ABC Australia iview and multi-language content, for the ABC iview Editorial team and internal stakeholders. Ensure curation plans are

- communicated and executed in a timely way, soliciting and taking feedback on board in a positive way.
- Plan and produce communications reporting on the performance and impact of content curation activities.
- Embrace a culture of experimentation, and a build, measure, learn approach to video content.
- Actively promote a team culture which is positive, collaborative, creative and engaged.
- Actively promote the ABC values and apply all relevant workplace policies and guidelines.
- Cooperate with any reasonable instruction, procedure or policy relating to safety and take
  reasonable care for your own safety and that of other people who may be affected by your
  conduct while at work. Additional WHS responsibilities apply to Managers and Supervisors, Team
