## **Purpose**

Drive the consolidation of requirements and analysis for digital product and platforms in order to facilitate solution designs for users and ABC content makers in line with ABC strategy and objectives.

## **Key Accountabilities**

- Under broad direction of the Technical Business Analyst Lead, perform highly specialised technical work as a core member of a cross-functional team and bring together business and systems analysis to support digital initiatives.
- Provide expert analysis for stated requirements of initiatives to determine and drive appropriate solutions for particularly complex design problems, in accordance with ABC technology standards.
- Evaluate the information gathered from workshops and task analysis to grow organisational knowledge and facilitate
  the design, implementation and documentation of particularly complex solutions from both content and
  technological perspectives.
- Partner with teams and peers to understand and identify the prioritised outcomes and work collaboratively to find
  the most effective way of achieving these outcomes together to support the delivery of team objectives and ABC's
  strategic plan.
- Oversee the planning and set up to configure content management systems, or similar platforms, that support content creation (e.g., CoreMedia, Zendesk, Stakla).
- Generate solution detailed design artefacts, such as process diagrams, basic architectural diagrams and technical documentation as required.

- In collaboration with relevant stakeholders, expertly design and implement solutions including developing and facilitating particularly complex workshops and creating detailed documentation.
- Develop or assist with the development of policy recommendations on particularly complex technical matters.
- Actively promote the ABC's values and apply all relevant workplace policies and guidelines.
- Cooperate with any reasonable instruction, procedure or policy relating to safety and take reasonable care for your own safety and that of other people who may be affected by your conduct while at work.
