ROLE CONTEXT

Primary Objective(s) of role:

The Aboriginal Primary Health Care Manager will use their clinical knowledge and experience to provide the pivotal co-ordination of client care delivery within the Aboriginal Health Team Northern. The main focus of this role is the line management, coordination and leadership of a multi-disciplinary team activities to achieve continuity and quality of client care / primary health care programs, services and outcomes.

The Aboriginal Primary Health Care Manager accepts accountability for the outcomes of multidisciplinary outcomes in the specific practice setting; for addressing inconsistencies between practice and policy; and for developing team performance and a positive work culture in the interest of client/community outcomes.

The Aboriginal Primary Health Care Manager is responsible for providing and maintaining high quality primary health and nursing care services to the Aboriginal community through the Indigenous Australians Health Program, Aboriginal social determinants and a holistic view of health including maintaining services via the Tarpari Wellbeing Centre.

Direct Reports:

Direct reports to this position include

- > Senior Aboriginal Health Worker (ASO4)
- > Chronic Disease Coordinator (RN2)

Key Relationships/ Interactions:Internal
