



COVID-19: SA Health Recruitment Drive Pharmacists/Pharmacy Frequently Asked Questions

Who can apply?

We are inviting all Pharmacists and Pharmacy Assistants, who are not already working in SA Health, to register their interest to work in existing or newly set up facilities, to provide and support the care that's required to respond to the COVID-19 pandemic across South Australia. There will be multiple positions available for:

- > Pharmacists
- > Pharmacy Assistants
- > Pharmacy Students

Pharmacists will require a Bachelor of Pharmacy or equivalent qualifications and either be registered or eligible for registration with the [Pharmacy Board of Australia](#).

What type of roles will be available?

The type of roles available will depend on the impact COVID-19 has on the public health system. When you apply, you will be asked to indicate your preferred work location/s (from our different [metropolitan health services](#) and [regional health services](#) across South Australia) and also to list any additional skills/qualifications/relevant experience that you have.

Where will the roles be working?

There will be various opportunities across the different Local Health Networks, including specialty areas. The location of roles will be dependent on demand and the impact that COVID-19 has on our healthcare services. Potential locations could include, but are not limited to all SA Health hospitals and health services (metropolitan and regional).

How do I apply?

Applications will only be accepted online. You can apply via the [COVID-19 SA Health Recruitment Drive](#)

What are the hours of work?

There will be a number of different shifts/hours available. There will be flexibility in rostering to match applicant availability and service requirements.

I have specific skills that I believe will help, how can I let you know?

If you have specific qualifications, experience and/or skills, you can enter the details as part of your online application.

Will I have to attend an interview?

A short telephone interview will be arranged to make sure we match applicants with appropriate roles. This will be an opportunity for you to let us know your roster requirements and the locations you would be willing to work.

Will I have to fulfil immunisation requirements?

Yes. As a condition of employment, you will be required to provide confirmation of immunisation status prior to commencement in any health care worker positions in SA Health. Please visit the SA Health website for more information about [Health Care Worker immunisation requirements](#).

Will I have to have a Criminal History clearance?

Yes. SA Health must comply with legislation regarding screening of workers for their suitability to work within SA Health. If you don't have a current clearance, this can be requested through an online, [accredited provider](#). You will not be able to commence a position with SA Health until your clearance has been attained.

As a minimum, SA Health requires an appropriate National Police Clearance (NPC) (for adult health services) or a Department of Human Services (DHS) Working with Children Check (for working with paediatric or adult services).

I have not heard anything from you yet, why not?

You will receive an email confirming that we have received your application. Shortlisting will be prioritised dependent on the clinical and service needs at the time. As you can appreciate, this is a busy time for the health services so we ask for your continued patience and understanding in this regard.

I want to help but I don't want to work with COVID-19 patients, can I work in a different area?

While this initiative is being undertaken to support the management of COVID-19, there will be a number of roles and locations to support the Local Health Networks and their health services. If you do not want to work in certain locations you can advise us during your telephone interview.
