ROLE CONTEXT

Primary Objective(s) of role:

Geriatrics Service Area provides comprehensive geriatric medicine service within NALHN. These services include, but will not be restricted to:

- > Geriatric Evaluation and Management Unit (GEM Modbury Hospital)
- > Community based Older Persons Health Service
- > Inpatient acute care of older people services
- > Inpatient geriatric consultative services.
- > Rural Consultative and Outpatient Service in the Inner North (based in Gawler & Port Pirie)
- > Care Awaiting Placement (Gawler/Parafield Gardens)

Contribute to the provision of high standard clinical services to patients of NALHN and referred to the area geriatrics service.

Contribute to teaching/training at undergraduates and postgraduate levels.

Participate in research.

Services will be provided across the NALHN and may include some visits to rural South Australia.

Key Relationships/ Interactions:

- > Immediately responsible to the Medical Head of Unit, Geriatrics.
- > Will be required to collaborate closely with other senior health professionals of NALHN, particularly those that form part of the Aged Care, Rehabilitation and Palliative Care Division.
- > Will be required to supervise the clinical practice of allocated trainee medical officers and medical students in the area geriatrics service.

Challenges associated with Role:

Major challenges currently associated with the role include:

- > Managing a busy workload and competing demands requiring the ability to organise and prioritise workload and time.
- > Working around patients / families / carers who may display distressed or unpredictable behaviour.
- > Maintaining personal boundaries when responding appropriately to client and family / carer expectations.

Special Conditions:

- > It is mandatory that no person, whether or not currently working in SA Health, will be eligible for appointment to a position in SA Health unless they have obtained a satisfactory Criminal and Relevant History Screening.
- > *Prescribed Positions* under the *Child Safety (Prohibited Person) Act (2016)* must obtain a satisfactory criminal and relevant history screening for child related work through the Screening Unit, Department of Human Services.
- > Criminal Screening and Relevant History screenings must be renewed every 5 years thereafter from date of issue for 'Prescribed Positions' under the *Child Safety (Prohibited Person) Act (2016)* or every 3 years thereafter from date of issue for 'Approved Aged Care Provider Positions' as defined under the *Accountability Principles 2014* made in pursuant to the *Aged Care Act 2007 (Cth)*.
- > Depending on work requirements the incumbent may be transferred to other locations across SA Health to perform work appropriate to classification, skills and capabilities either on a permanent or temporary basis subject to relevant provisions of the *Public Sector Act 2009* for Public Sector employees or the *SA Health (Health Care Act) Human Resources Manual* for Health Care Act employees.
- > The incumbent may be required to participate in Counter Disaster activities including attendance, as required, at training programs and exercises to develop the necessary skills required to participate in responses in the event of a disaster and/or major incident.
- > Appointment is subject to immunisation risk category requirements (see page 1). There may be ongoing immunisation requirements that must be met.

Northern Adelaide Local Health Network

The Northern Adelaide Local Health Network (NALHN) provides care to more than 400,000 people living in the northern metropolitan area of Adelaide as well as providing a number of state-wide services, and services to those in regional areas. NALHN works to ensure quality and timely delivery of health care, whilst building a highly skilled, engaged and resilient workforce based on a culture of collaboration, respect, integrity and accountability.

NALHN offers a range of primary health care services across the northern metropolitan area of Adelaide, with a focus on providing preventive and health promoting programs in the community, and transition and hospital substitution and avoidance programs targeted at chronic disease and frail aged.

Clinical leadership of care systems is central to the current national and state wide health reforms. NALHN care delivery is configured within clinical divisions that are patient-focused, clinically led groupings of services. Clinical Divisions are responsible for managing service delivery activities across NALHN campuses and units, bringing together empowered experts to directly make relevant decisions.

NALHN includes:

- > Modbury Hospital is a 174-bed, acute care teaching hospital that provides inpatient, outpatient, emergency services, Aged Care, Rehabilitation and Palliative Care. GP Plus Health Care Centres and Super Clinics
- > Aboriginal Health Services
- > Mental Health Services (including two statewide services – Forensics and Older Persons)
- > Sub-acute Services

The total operating budget for 19/20 for NALHN is \$790M with a workforce of 3,857 FTE / 5,240 head count.
