ROLE CONTEXT

Primary Objective(s) of role:
<p>The Transition to Professional Practice Program (TPPP) Registered Nurse (RN) program aims to support the newly qualified RNs to consolidate and develop skills and knowledge reflected in high quality nursing practice.</p> <p>The YNLHN TPPP Registered Midwifery (RM) program will enable newly graduated Midwives to be part of YNLHN Midwifery Group Practice which is a woman centred caseload midwifery program across the region.</p> <p>The transition program is a twelve-month evidence-based, developed by rural nurses and midwives and informed by the practical experience of our rural and regional workforce. Participants in the Yorke and Northern LHN TPPP can expect a program that offers support and opportunities in developing nursing and midwifery practice of the highest quality. The program operates across the region, and all participants are offered similar opportunities. This program is dedicated to:</p> <ul style="list-style-type: none"> • Providing support to newly graduated transitioning nurses and midwives across YNLHN • Recognising the unique nature of working regionally and rurally • Focusing on the skill development relevant to these areas of nursing and midwifery • Using an evidence-based curriculum to further develop a strong and high-quality nursing and midwifery workforce • Offering unique opportunities for TPPPs specific to the YNLHN. <p>Employees classified at this level provide nursing and/or midwifery services in health service settings. Employees working within this level develop from novice practitioners to a proficient level of professional practice. They consolidate knowledge and skills and develop in capability through continuous professional</p>

development and experience. An employee at this level accepts accountability for his or her own standards of nursing/midwifery care and for activities delegated to others.

- > Approved Aged Care Provider Positions as defined under the Accountability Principles 1998 made in pursuant to the Aged Care Act 2007 (Cth) must obtain a satisfactory National Police Certificate (NPC) through the South Australian Police confirming the clearance is for the purpose of unsupervised contact with vulnerable groups.

This includes the townships of Balaklava, Booleroo Centre, Burra, Crystal Brook, Clare, Jamestown, Laura, Maitland, Minlaton, Orroroo, Peterborough, Port Broughton, Port Pirie, Riverton, Snowtown, Wallaroo and Yorketown.
