ROLE CONTEXT

Primary Objective(s) of role:

- Be a member of the urology team actively involved in the roster for timely assessment of patients who present to the emergency department, are referred from other hospitals or from general practitioners in the community with acute urological conditions.
- Be a member of the urology team responsible for the timely assessment of inpatient referrals from other specialist units.
- The doctor will participate in the on call roster for urology registrar cover at The Queen Elizabeth Hospital (TQEH). During such cover they will have the support of the on call urology consultant for both clinical decision making and surgical interventions.
- Be an active member of the urology team in ensuring the safe, efficient and well documented management of urology inpatients at TQEH and be involved in the assistance and teaching of the unit's intern and resident medical officer.
- The doctor will have allocated outpatient and supervised theatre responsibilities with a view to develop their knowledge and clinical urological skills and assist in their preparation for Urology Surgical Education and Training (SET) application. Over 12 months, the unit will assist the service registrar in obtaining proficiency in surgical procedures including scrotal exploration +/- orchidopexy, flexible cystoscopy, cystoscopy + ureteric stent insertion and bladder biopsy. The ability of the incumbent to progress onto more complex surgical procedures will be judged by the supervising consultants.

- A requirement tto participate on the after hour's on-call roster on a regular basis.
- Balancing commitment to elective and emergency work to obtain the best outcomes for both.
- Urology is a high demand service, clinics can be demanding, time management & the ability to prioritise is essential.

- Competent surgical practice and technique is not a requirement for application to this position.
- Experience in collaborative problem solving.

Special Conditions:

- It is mandatory that no person, whether or not already working in SA Health, may be appointed to a position in SA Health unless they have provided a satisfactory current Criminal and Relevant History Screening, as required by the SA Health Criminal and Relevant History Screening Policy Directive.
- For appointment in a Prescribed Position under the Child Safety (Prohibited Persons) Act (2016), a current Working with Children Check (WWCC) is required from the Department for Human Services Screening Unit. For other positions, a satisfactory National Police Certificate (NPC) assessment is required.
- For 'Prescribed Positions' under the Child Safety (Prohibited Persons) Act (2016), the individual's WWCCs must be renewed every 5 years from the date of issue; and for 'Approved Aged Care Provider Positions' every 3 years from date of issue as required by the Accountability Principles 2014 issued pursuant to the Aged Care Act 1997 (Cth).
- Appointment is subject to immunisation risk category requirements. There may be ongoing immunisation requirements that must be met.
- Depending on work requirements the incumbent may be transferred to other locations across SA Health
 to perform work appropriate to classification, skills and capabilities either on a permanent or temporary
 basis subject to relevant provisions of the *Public Sector Act 2009* for Public Sector employees or the
 SA Health (Health Care Act) Human Resources Manual for Health Care Act employees.
- The incumbent may be required to participate in Counter Disaster activities including attendance, as required, at training programs and exercises to develop the necessary skills required to participate in responses in the event of a disaster and/or major incident.

SA Health Challenges:

The health system is facing the challenges of an ageing population, increased incidence of chronic disease, workforce shortages, and ageing infrastructure. The SA Health Care Plan has been developed to meet these challenges and ensure South Australian's have access to the best available health care in hospitals, health care centres and through GPs and other providers.

Central Adelaide Local Health Network:

Established in July 2011, CALHN is one of five Local Health Networks (LHNs) in South Australia and we are accountable to the Central Adelaide Local Health Network Governing Board. CALHN also has governance over numerous community mental health and primary health services including Prison Health Service, SA Dental Service and DonateLife SA. Of note also is governance of the Statewide Clinical Support Services (SCSS) including SA Medical Imaging (SAMI), SA Pathology SA Pharmacy and BreastScreenSA, responsibility of which has vacillated between CALHN and DHW over the past few years.

CALHN is one of three metropolitan LHNs and its core population is approximately 390,000 people. CALHN also provides services to patients from other SA networks, rural and remote areas, the Northern Territory, NSW (Broken Hill) and western parts of Victoria. These services usually relate to complex services such as head and neck cancer, radiation therapy, cardiac surgery, spinal surgery or rehabilitation.

CALHN's purpose is to deliver quality and sustainable healthcare. While the delivery of high-quality patient care is our number one priority, underpinning our goals is good governance, improved patient experience, business operations, efficiency and financial performance and more accountable and contemporary ways of working.
