Position Purpose

This position will provide routine engineering advice and manage minor construction projects which meets the needs of Council's residents and ratepayers.

Key Responsibilities and Outcomes

As an Engineer within Project Development and Delivery you will:

- Manage a workload of minor construction projects (up to \$500K) under limited supervision including the administration, supervision and management of contracts through stages of procurement, award, construction, defects liability and maintenance periods.
- Undertake routine technical planning and investigation of projects (as assigned) including the investigation of alternate solutions, cost estimation and constructability considerations; and generate technical reports for Senior Engineer's review and consideration.
- Provide routine technical engineering advice and ensure engineering work are undertaken in accordance with current construction legislation, Australian standards, Workplace Health and Safety requirements and accepted work practices.
- Manage the infrastructure design process including coordination and management of contractors to ensure projects are run to schedule. Resolve routine construction issues associated with minor construction projects.
- Assess, recommend and reject progressive payment certificate claims made by contractors up to the accumulated value of the project.
- Contribute to a positive team environment in order to achieve a high performance, continuous improvement and customer focused culture.
- Engage proactively with internal and external stakeholders to ensure project deliverables and outcomes are achieved.
