Purpose of Role

Provide best practice transport planning and network modelling advice and develop sustainable solutions for establishing future transport networks within the Moreton Bay Region that are consistent with population growth and are aligned to Council's policy and strategy.

Specific Responsibilities

- Use expert technical knowledge to advise on current best practice integrated transport planning solutions and practices that are context sensitive and consistent with adopted policies. Prepare comprehensive reports and make recommendations on the region's future transport needs.
- Provide functional oversight of the development and evolution of the regional strategic land use / transport model operating in close partnership with the Department of Transport and Main Roads to ensure consistency of forecasting.
- Undertake reviews of best practice mode share planning and facilitation solutions, including impacts of emerging intelligent transport systems, and develop plans, policies and strategies for Council to adopt to utilise in network modelling scenarios.
- Assist in the development of Council's Local Government Infrastructure Planning (LGIP) in coordination with cross divisional teams and input projects into Council's capital and operational works programs for long term financial forecasting and development of transport networks.
- Integrate modal change frameworks as a primary outcome of future transport network planning with a strong focus on passenger transport and active travel.
- Serve as a technical resource to Council officers, elected members, and the public regarding transportation planning policy, transport planning, strategy and vision.
- Represent Council's interests in meetings with the external consultants, developers and State Government agencies. layouts, P50 cost estimates and preparation of design briefs.
- Manage relationships with internal and external stakeholders, suppliers and contractors to optimise service outcomes including one network transport solutions with the various Queensland State Government transport departments with a strong emphasis on solutions that promote and facilitate modal change in a rapidly growing metropolitan region.
- Develop evidence-based integrated transport solutions that include intelligent transport solutions, complete streets, urban design, placemaking and activation public space principles as required.
