In partnership with the National Boards, AHPRA's, Regulatory Operations Directorate, Registration division ensure only practitioners who have the skills and qualifications to provide safe care to the Australian community are registered to practise their profession. AHPRA publishes registers of practitioners (the national register) so that important information about the registration of individual health practitioners is available to the public.

### Role purpose

Reporting to the Regulatory Advisor Registration – (Team Leader Admin), the Regulatory Assistant – Registration will undertake reception duties and provide comprehensive administration and support services to the registration teams across all aspects of the registration function within established national policies and procedures with a focus on AHPRA's values to deliver high performance.

### Key Accountabilities

- Provide efficient and courteous service to customers at reception on a rotating basis, including greeting the public, answering routine enquiries and directing the public on how to contact appropriate AHPRA staff.
- Undertake reception duties, including processing and reconciling of payments and other financial transactions, receipt and processing of documents and adhering to the procedures when transferring these to other business units.
- Complete administrative support activities within registration including preliminary data entry of applications, conducting legacy checks and issuing of certificates of registration status within established timeframes and established national policies and processes.
- Other duties as directed by the Regulatory Advisor – Registration (Team Leader Admin).
- Health Safety and Wellbeing: Ensuring the workplace provides a safe working environment with the required level of care and respect for its participants. This means to:
  - Take reasonable care for own and others' health, safety and wellbeing;
  - Adhere to AHPRA's workplace health, safety and wellbeing policies and procedures.
