Organisation Overview

The Catholic Education, Archdiocese of Canberra and Goulburn (CECG) plays a crucial role in education in both the Australian Capital Territory (ACT) and New South Wales (NSW). It covers 88,000 square kilometres, encompassing the entire ACT and extending from Pambula on the south coast to Crookwell in the north and to the western point of Lake Cargelligo. CECG operates 56 schools and nine early learning centres and is responsible for educating over 22,000 students. It also employs over 4,000 professionals who are the driving force behind our education system.

Position Overview	The Teacher Librarian is responsible for advancing student's information literacy and critical thinking skills while also managing the library to support the school's academic and educational goals. The Teacher Librarian works collaboratively with Classroom Teachers to integrate information and digital literacy skills into the curriculum, fostering a love for reading and lifelong learning among students. They are responsible for curating a diverse and inclusive collection of resources—both print and digital—that meet the learning needs of students and the resource needs of staff. Additionally, they play a crucial role in helping students and staff navigate, evaluate, and ethically use information in various formats.

Actively engage students in the use of digital technologies. Promote print and digital resources including library management system and subscription databases. Provide relevant resources for the classroom teachers and students. Use the library management system and oversee the cataloguing of resources. Manage library staff, parent volunteers and library monitors. Promote knowledge of and passion for children's literature. Collaborate with staff in the coordination of Book Week celebrations, Book Fair and Book Club organisations.
