# **Position Summary**

The Research Associate will work within the Population Child Health Clinical Research Group, School of Clinical Medicine UNSW. They will support research service and develop novel research by increasing quality publication output and grant income with the ultimate aim of improving the health, wellbeing and development of children and young people locally, nationally and internationally.

This position will have a particular focus on mixed methods implementation evaluation of paediatric models of health care. They will work on several studies including the PEACH (Providing Enhanced Access to Child Health Services) study and the MRFF funded Transition Compass study. The PEACH study is an embedded translational research programme set up to improve equity of access for priority populations across the Sydney Children's Hospital's Network. Transition Compass is an MRFF funded study assessing a novel model of care to aid transition from paediatric to adult services.

The post holder will report to the Professor, Head of the Research Group.

Specific accountabilities for this role include:

- Contribute independently or as a team member in collaborative research with a focus to enhance the quality of research outcomes in the discipline area.
- Conduct research (as per the norms of the discipline) and/or enable research teams to create scholarly output that is recognised by peers.
- Carry out systematic reviews around health systems/health services research. Prepare and write the report for submission and peer reviewed papers. Perform additional research related tasks as required within the Child Health Population Research Group.
- Support the dissemination of research outcomes through appropriate channels and outlets.
- Undertake discipline-appropriate research activities, e.g. surveys, literature reviews, data gathering and/or recording of results using appropriate research methods.
- Participate in and/or present at conferences and/or workshops relevant to the project as required.
- Assist with the supervision of research students in the research area where required.
- Assist with the ethics and grant applications process by writing and submitting applications under supervision from the Population Child Health Group.
- Perform qualitative interviews and focus groups with children, parents and health care providers. Conduct qualitative and quantitative analysis of ongoing projects.
