
Charles Sturt Dental and Oral Health Clinics

The Clinics offer both fee-for-service dental services undertaken by fully qualified and experienced dentists and supervised student dental and oral health services.

The Dental and Oral Health Clinics in collaboration with the Centre for Rural Dentistry and Oral Health are committed to delivering high quality and sustainable dental education programs, engaging in translational clinical research, building the dental and oral healthcare workforce, and making a significant contribution to improving the oral health and quality of life in regional, rural, and remote NSW.

Position overview

The Dental Residency Program aims to provide an early career clinical and academic development opportunity to a recent graduate dentist seeking to advance their career in a supportive, team driven, highly functional, intellectually stimulating, and large University practice. Through a supportive employment model, mentorship will be provided, along with opportunities for further study, including enrolment in a Bachelor of Science (Hons) or a Higher Degree by Research or training with the Royal Australasian College of Dental Surgeons.

During academic sessions, the Dental Resident will work in the Charles Sturt Dental and Oral Health clinics three days per week, providing routine dental work requiring independent examination, diagnosis, treatment planning and treatment for patients. One to two days per week residents may supervise dental and/or oral health therapy students in their teaching and learning environments. During academic session breaks residents will be required to see patients five days per week. General oversight will be provided by more experienced dentists and academic staff members and

- Establishment of informed treatment consent including financial consent resulting from appropriate discussion and documentation of all information relevant to the treatment of each patient within the patient's dental record and /or in the computerised Patient Management
- Ethically appropriate billing of patients through effective use of the Charles Sturt University

- C. Demonstrated ability to exercise clinical reasoning, independent judgement and problem solving in clinical practice.
- Excellent oral and written communication skills and the ability to liaise effectively and sensitively with a wide range of individuals.
- E. A commitment to develop the knowledge and skills necessary to supervise dental and/or oral health therapy students in their teaching and learning environments.
- F. Demonstrated ability to work collaboratively as part of a team.
