## **Position purpose**

The appointee will support and maintain the school's drive for excellence in teaching, curriculum design and architecture, professional activities and policy development that underpin the discipline of Chemistry as aligned with the faculty, University and the community. The Associate Professor, Polymer Chemistry will also be active in the profession, have relevant industry networks and be willing to assume senior administrative functions.

### **Key Responsibilities**

#### Research and education

- 1. Engage actively in high-quality, internationally recognised research
- 2. Support and foster the research of colleagues and the obtaining of external research funding
- 3. Supervise the program of study of honours students and of postgraduate students engaged in course work
- 4. Supervise honours research projects and postgraduate research theses
- 5. Contribute to teaching and curriculum development
- 6. Make a personal contribution to the teaching program in a relevant discipline

#### Leadership and management

- 1. Contribute to academic and administrative leadership within the school and participate in the development of policy in the school, faculty and University
- 2. Actively engage with industry and support key project work aligned with industry requirements
- 3. Conduct performance management reviews and engage in mentoring academic staff as appropriate
- 4. Perform administrative and coordinator duties that are necessary for the effective operation of the programs including subject/course coordination
- 5. Actively participate in the strategic development and administration of the school and represent its interests, views and needs in the broader faculty and University contexts

- 1. Engage with and maintain collaborative linkages and provide advice to government and other relevant community organisations on relevant matters
- 2. Strengthen links with relevant faculties and schools within the University
- 3. Promote Polymer Chemistry as a discipline to potential students and the wider community

- 5. Developed skills of leadership, networking and management
- 6. Willingness and capacity to make a substantial contribution to all activities of the school including administration and planning
- 7. Professional leadership qualities and capacity for executive administrative responsibilities

- 8. Excellent communication skills and ability to liaise well with other academics
- 9. Potential to forge relationships with industry-focused Polymer Chemistry programs
- 10. A vision for the future needs and development of Polymer Chemistry within Australia and internationally, from research and educational perspectives
