## Position purpose

As Director Entrepreneurship the appointee will be expected to provide strategic leadership to the school and coordinate initiatives related to entrepreneurship, innovation and commercialisation. The appointee will be a member of the faculty executive and will be expected to contribute to the development of the faculty strategic plan. The appointee will play a crucial role in leading the School's undergraduate, postgraduate and executive-level teaching and educational programs in entrepreneurship, coordinating the School's activities in the entrepreneurship area including interactions with other entrepreneurship activities across Monash University, sourcing and implementing entrepreneurship projects and will inspire staff with a strong vision for entrepreneurship education, engagement and research.

As a Professor the appointee will be expected to provide leadership and foster excellence in research, teaching, professional activities and policy development within the Monash Business School, the Faculty of Business and Economics and the wider university. In line with the faculty plan, the appointee will be expected to develop and implement strategies to strengthen links with industry, build research capacity, develop innovative educational programs and advance the discipline of entrepreneurship within the national and international community.

**Reporting Line:** The position reports to the Deputy Dean, Leadership and Executive Education, Monash Business School

**Supervisory responsibilities:** The appointee will be responsible for the supervision of faculty and associates undertaking teaching, project supervision and other development activities and initiatives in the entrepreneurship area.

## Key responsibilities

1. Actively engage, lead and coordinate School initiatives related to entrepreneurship, innovation and commercialisation aligned with the Faculty strategy and aspirations to strengthen the School's engagement with internal and external stakeholders in the field of entrepreneurship
2. Foster research excellence in the field of entrepreneurship through procuring competitive research grants, collaborative research opportunities, undertaking research, publishing, and encouraging inter-disciplinary research in the field
3. Coordination and sourcing of entrepreneurship, innovation and commercialisation projects for undergraduate, postgraduate, MBA and executive education programs as well as other developmental programs sponsored by the School and the University
4. Provide strong and committed leadership in entrepreneurship teaching, curriculum development and research training by participating in the faculty's curriculum planning and development processes, academic committees, and relevant examination processes in addition to monitoring the quality of individual teaching in the discipline
5. Provide innovative and effective leadership for the development and growth of entrepreneurship programs in both degree programs and executive education including, but not limited to, the BEX3411 Innovation and Entrepreneurship and BEX5411 Creativity and Entrepreneurship units
6. Contribute to academic and administrative leadership within the faculty by participating in the development of policy and strategy including coordination of the School's relationship with entrepreneurship activities in other faculties, the Generator/Monash Entrepreneurship Office, as well as other related university entrepreneurship activities sponsored by the Deputy Vice-Chancellor Enterprise, the Vice-Provost Research and Research Infrastructure, and the Monash Industry Team Initiative
7. Maintain and broaden collaborative partnerships relating to entrepreneurship activities with relevant faculties and departments/schools within the University and community
8. Maintain and broaden collaborative partnerships with external agencies both nationally and internationally, making a significant contribution to the profession and contributing to the School's reputation for thought leadership in entrepreneurship by contributing to current debates and thinking
9. Actively contribute to partnering with industry and diversifying funding avenues, including supervision of industry based learning projects undertaken by students in the Entrepreneurship specialisation specifically BEX5012 Industry based learning project

  - PhD in any field relevant to entrepreneurship or equivalent experience and professional standing

2. Evidence of outstanding scholarly activity and/or professional or business experience of an international standard in entrepreneurship, innovation or commercialisation

3. Demonstrated ability to generate revenue from educational, applied research, consulting and/or entrepreneurship activities
4. Record of leading successful entrepreneurship, innovation and/ or commercialisation activities and initiatives in a business, professional, research or University setting
5. Proven excellence in teaching or professional development activities including the design, development and delivery of entrepreneurship and innovation educational, training or development programs
6. Willingness and capacity to make a substantial contribution to all activities of the Leadership and Executive Education portfolio and the entrepreneurship and innovation activities of the School, including, strategic planning, academic leadership, administration, teaching, supervision and executive education delivery
7. Proven professional leadership qualities and capacity for executive administrative responsibilities
8. Evidence of sustained relationships with industry, business, government agencies, professional bodies in the field of entrepreneurship coupled with vision for the future needs and development of entrepreneurship within Australia and internationally
