- 4. Contribute to the supervision of students at undergraduate, honours, graduate coursework and research levels.
- 5. Contribute to teaching at undergraduate and postgraduate levels as required. Teaching duties include, but are not limited to the preparation and delivery of lectures and tutorials, course design, preparation of online material, marking and assessment and consultations with students.
- 6. Outreach to the community including prospective students, research institutes, government, the media and the public.
- Comply with all ANU policies and procedures and in particular those relating to work health and safety and equal opportunity.
- 8. Other duties as required consistent with the classification level.

# Level C

- 4. Contribute to the supervision of students at undergraduate, honours, graduate coursework and research levels.

- 5. Contribute to teaching at undergraduate and postgraduate levels as required. Teaching duties include, but are not limited to the preparation and delivery of lectures and tutorials, course design, preparation of online material, marking and assessment and consultations with students.
- Outreach to the community including prospective students, research institutes, government, the media and the public.
