Position Summary

This is an exciting opportunity to participate in cutting-edge research in statistical genetics. You will work with Professor Balding to develop and apply new models for traits of interest – such as disease risk or physical characteristics – from genome-wide genetic predictors. Our goal is a unified model for learning about genetic mechanisms, for predicting disease risk or progression, and for predicting drug response. The models will be applied to large genomic datasets in public databases or available through collaborators. We will work in collaboration with Dr Doug Speed, based in London and Aarhus, Denmark, developing work published recently in Nature Genetics (doi: 10.1038/ng.3865). A research visit to one or both of these cities will be available, subject to satisfactory progress.

1. Key Responsibilities

- With support from senior academic staff, undertake research in computational statistical genetics using large-scale public genomic databases.
- Based on research results, assist in the development computer code that is suitable for practical application of other researchers.
- Contribute to the production of reports, conference and seminar papers and publications based on research findings.
- Undertake administrative functions primarily connected to the area of research.
- Attend meetings associated with research and School and Faculty meetings as well as assuming membership of a limited number of committees, where appropriate.
- Occupational Health and Safety (OH&S) and Environmental Health and Safety (EH&S) responsibilities as outlined in section 4.

2. Selection Criteria

2.1 ESSENTIAL

- A PhD in statistics, computational biology, computer science, mathematics or any other field with a strong statistical and computational component.
- Strong computing skills including programming in a scientific and/or statistical language (e.g. C++, Java, R, Python, Perl)
- Knowledge of relevant statistical techniques, and experience of statistical analysis of large and complex datasets.
- High-level organisational and time-management skills and a demonstrated capacity to manage competing priorities and bring projects to timely completion
- Strong oral and written communication skills in English.
- Excellent interpersonal skills with a demonstrated ability to interact positively and work co-operatively in a multi-disciplinary team environment and liaise with people from diverse backgrounds.

2.2 DESIRABLE

- Experience with accessing and using large-scale public genomic databases.
- Knowledge of the basic vocabulary of genetics, the key processes that lead from genotype to phenotype and the principles of population genetics.

5.1 ORGANISATION UNIT

Professor Balding holds joint appointments in the School of BioSciences and in the School of Mathematics & Statistics. The incumbent will have administrative home in Mathematics & Statistics but will work with Prof Balding in the Centre for Systems Genomics which is hosted by both Schools.

The University of Melbourne's School of Mathematics and Statistics is one of Australia's leading mathematics and statistics schools. It has achieved this status through the high quality of its research and teaching programs. The School offers a wide range of subjects to undergraduate and postgraduate students and is involved in aspects of community life that impact on the interests of the School and the discipline.

Special facilities such as high end workstations and salaries for research fellows are supported through individual competitive external research grants. Members of the School have had considerable success at attracting support from the Australian Research Council. The School hosts two ARC Centres of Excellence, has several ARC Laureate, Future and DECRA Fellows.

It is one of the objectives of the University to develop and maintain a strong international profile. In this context, members of the School have strong collaborative links with colleagues in the United States of States of America, most countries in Europe and the Asia-Pacific region.
