## **Position Summary**

This position is part of a research team coordinated by Professor Anthony Bebbington and working on his ARC Laureate Fellowship project, "Mining and Society in a Changing Environment: Pathways to Sustainability". The role involves original research in Latin America and/or Indonesia, the organization of research workshops, mentoring support to students and a range of communication activities. The position will develop work on extractive industries, environment and society within the School of Geography and the University and contribute to the building a research centre around these issues.

## 1. Key Responsibilities

- Undertake fieldwork, data collection, data analysis and literature review to meet Laureate Fellowship programme requirements.
- Publish papers with other team members and as sole author in fields relevant to humanenvironment geography, extractive industries, climate change, and development geography
- Present research programme and findings to diverse audiences, and build relationships with these audiences
- Assist with supervision and mentoring of research assistants, doctoral, master's and honours research students involved in the wider research programme
- Collaborate with other Research Fellows in the project to combine human-environmental science and GIS based analyses and outputs
- Creation and maintenance of a research programme website and other communication channels with diverse audiences within and beyond academia, including in industry, the non-governmental sector, the corporate sector, government and broader public domain
- Organization and coordination of occasional events, seminars and reading groups related to the themes of the project
- Assist in the preparation of proposals and submissions to external funding bodies.
- Undertake research reporting tasks in relation to project outcomes, expenditures and ethical approvals.

## 2. Selection Criteria

- PhD in the social or management sciences related to natural resource governance.
- Demonstrated ability to conduct high quality research and to produce publications for academic and policy or popular audiences.
- Demonstrated expertise in social science research methods, and ability to conduct research in diverse social and institutional contexts
- Demonstrated knowledge of mining and natural resource governance, in at least one of the Australian, Latin American, South East Asian or Pacific contexts
- Fluency in one of Spanish or Bahasa Indonesia as well as English
- General computer skills and capacity to apply, and learn if needed, advanced packages such as QSR's NVivo, Filemaker and/or SPSS.

- Excellent communication, teamwork and project management skills.
- Demonstrated understanding of University research ethics protocols.
