The advertised position is located within the **School of Media, Film and Journalism**. Based on the Caulfield campus, the School was formed in 2014 and its staff conducts research in media studies, communications studies, cultural studies, journalism, film theory and criticism, media practice and related interdisciplinary fields. The School offers programs and teaching at undergraduate, honours and postgraduate levels. It also houses a number of active interdisciplinary research units, has a wide network of national and international connections, and engages in international research collaborations. http://artsonline.monash.edu.au/mfj/

The Communications and Media Studies (C&MS) program operates within the School of Media, Film and Journalism. Researchers are engaged in a series of internationally-focussed projects that explain what it means to live in an age of powerful media and cultural institutions, proliferating digital and mobile technologies, and everyday media and cultural practices (e.g. social networking, surveillance, datafication). C&MS at Monash is also home to an agenda-setting 'Culture, Media, Economy' Research Focus Program (<a href="https://arts.monash.edu/research/focus-programs/culture-media-economy/">https://arts.monash.edu/research/focus-programs/culture-media-economy/</a>).

**C&MS** research was rated as 'above world standard' in the 2015 ERA Exercise. Australian Research Council funded projects of staff include investigations into global media sport and mobile communications, urban cultural policy and cultural production, the economic and cultural dimensions of music exports, environmental conflict and media, creative vocations in Australia and China, the significance of music cities, and the exchange between 'fringe' and 'mainstream' cultural practices. Staff also supervise a wide range of PhD and Masters-by-Research projects.

Teaching in C&MS focusses on creating graduates who are critically informed citizens, professionals and consumers able to negotiate the challenges and opportunities of a global, networked media age. This is achieved by examining how media and communications shape the world in which students live, and the role they can play in changing this world for the better though their media practices, decisions and experiences. C&MS offers an undergraduate major to Honours level in the Bachelor of Arts, and the Media specialisation in the Bachelor of Media Communications. It has thriving graduate programs in the Master of Communications and Media Studies and the Master of Cultural and Creative Industries.

## **Position Purpose**

A Level C academic is expected to make significant contributions to the teaching effort of a department, school, faculty or other organisational unit or an interdisciplinary area. An academic at this level is also expected to play a major role in developing and conducting academic and/or industry focused research and contribute to the development and engagement of the Department.

A Level C academic will be required to demonstrate this capacity by a record that includes evidence of quality refereed publications, competitive grant funding, and Higher Degree Research (HDR) supervision experience and/or completions.

The successful appointee will coordinate units, prepare and present lectures and/or seminars, undertake marking, contribute to curriculum development, and supervise Honours and HDR students. The units in which they will be involved will be negotiated on appointment and will change over time.

A Level C academic will be required to develop new units for the programs and potentially undertake a section level leadership role.

#### **Key Responsibilities**

Specific duties required of a Level C academic may include:

- 1. The preparation and conduct of tutorials, practical classes, demonstrations, workshops, student field excursions, clinical sessions and studio sessions
- 2. Coordination, initiation and development of course material
- 3. Supervision of major honours or postgraduate research projects
- 4. Supervision of the program of study of honours students and of postgraduate students engaged in course work
- 5. The conduct of research and dissemination of research findings through publications in highly reputable journals and other outlets
- 6. Significant role in research projects including, where appropriate, leadership of a research team in Communications and Media Studies
- 7. Submitting applications for external funding
- 8. Consultation with students
- 9. Engagement with industry as appropriate
- 10. Broad administrative functions, the majority of which are connected with the subjects in which the academic teaches, such as marking and assessment
- 11. Attendance at departmental, school and/or faculty meetings and a major role in planning or committee work
- 12. Embrace and support the faculty's commitment to national and international accreditation (i.e. TEQSA, EQUIS, AACSB and AMBA)
- 13. Recognise and uphold the faculty's commitment to the principles and values promoted through PRME and GRLI in all activities

## **Key Selection Criteria**

#### **Education/Qualifications**

- 1. The appointee will have:
  - A PhD in a relevant discipline/field

#### **Knowledge and Skills**

- 2. A track record in research, as evidenced by national and international publications, and engagement of research partners. This should include expertise in the following: data analysis, data visualisation and digital research methods, including knowledge of theoretical perspectives and critical traditions
- 3. Demonstrated strong record of teaching experience in a tertiary environment, including evidence of leadership in teaching
- 4. A track record of successful Higher Degree Research supervision
- 5. Possess a high level of interpersonal skills and demonstrated ability to work independently and as part of a team across both the education and service sectors
- 6. A willingness to undertake service at the departmental and/or Faculty level
- 7. Ability to work positively and cooperatively with students, internal and external teams and agencies
- 8. A demonstrated capacity to work in a collegiate manner with other staff in the workplace
