### THIS ROLE EXISTS TO: (PURPOSE)

The function of the Network Transfer Officer is to work collaboratively across water supply operations with internal stakeholders to ensure optimal operation of the water transfer network. The network transfer officer will have broad understanding of hydraulic engineering concepts and will provide advice and expertise in bulk water transfer across the Melbourne region. You will provide support in the planning, coordination and delivery of the outage program, integration of new transfer assets, and maintenance of existing transfer assets, and in the delivery of new programs to ensure optimum efficiency of the network.

#### **KEY ACCOUNTABILITIES:**

- Taking care of own and colleagues Health and Safety through identification and reporting of hazards and active involvement in improvement initiatives.
- Work within the Outages and Asset Integration team under limited supervision, to ensure transfer operations are effective, efficient and optimised to best benefit the strategic goals of the business.
- Plan, coordinate and deliver scheduled and unscheduled outages within the water supply network under supervision and instruction from senior officers in the Network and Strategic Water operation team
- Deal with complex and abstract technical issues and changing priorities and/or different situations requiring use of their judgement or experience in water transfer networks
- Work with internal stakeholders to manage the integration of new assets into the water supply system, including documenting processes and systems, managing associated outages and the testing and commissioning of new assets.
- Act as a liaison point for internal stakeholders on water operational topics and partake in incident investigations and debriefs as requested.
- Provide technical operational advice to Water Supply Operators and others within Melbourne Water on water supply transfer and water quality issues.
- Assist in the development and delivery of transfer network improvements.
- Provide operations representation on capital projects as requested to improve functional design, delivery, commissioning and handover of water projects
- Develop and review OCCP's, SOP's, Contingency Plans and other controlled documents as designated
- Take care of own and colleagues Health and Safety through identification and reporting of hazards and active involvement in improvement initiatives.
- Maintain awareness of how their work relates to other activities and the ongoing operation of the organization
- Key operational contact for Other Authority Works approvals and manage allocation of resources for field interactions
