| Purpose                   | The Peer Practitioner utilises their lived experience of mental ill health and recovery to provide services to clients, families and carers in line with Mind's Model of Recovery Oriented Practice, My Better Life model and organisational values for people with a psychosocial disability. The Peer Practitioner is expected to be a champion of co-design and co-production in all aspects of the service, work with clients to define their own outcomes and deliver personalised support services and recovery-oriented care to people living with mental ill health in the community.  Peer support is an important part of Mind's approach to recovery. The Peer Practitioner works as part of a multidisciplinary team with lived experience of mental ill health and recovery being the unique specialist lens that they bring. |

| About the service         | The Connect program is an outreach service that delivers intensive support for up to 12 weeks to individuals with mental health and wellbeing issues within a framework of recovery that is focused on strengths and capabilities. Connect is delivered by a Peer Practitioner workforce providing support to clients who are experiencing distress and crisis to avoid hospital presentations and admissions or to support clients to return home from a hospital setting at the earliest possible time.  Peer Practitioners work with individuals and their families and carers delivering case management services and assistance with establishing relationships with key service providers to ensure a coordinated,   |
