## Summary of the broad purpose of the role in relation to the organisation's goals

The Kitchen Hand is responsible for providing a timely, efficient and effective catering service within the health unit. Duties may include the preparation, service and delivery of food to clients.

The Kitchen Hand may be required to work within a number of areas of the health unit including kitchen, laundry and housekeeping.

## Reporting/Working Relationships

The Kitchen Hand is responsible directly to the General Service Team Leader on a day to day basis and ultimately responsible to the Manager of General Services.

## **Confidentiality and Handling of Official Information**

By virtue of their duties, SA Health employees frequently access, otherwise deal with, and/or are aware of, information that needs to be treated as confidential.

SA Health employees will not access or attempt to access official information, including confidential patient information other than in connection with the performance by them of their duties and/or as authorised.

- > Risk-Assessed roles under the National Disability Insurance Scheme (Practice Standards – Worker Screening Rules 2018) must obtain a satisfactory NDIS Worker Screening Check through the Department of Human Services (DHS) Screening Unit.
- > National Police Certificates must be renewed every 3 years thereafter from date of issue.
- Working With Children Checks must be renewed every 5 years thereafter from date of issue.

- Must be flexible and willing to participate in a 7 day roster working varied hours/shifts across different settings.
- > Appointment is subject to immunisation risk category requirements (see page 1). There may be ongoing immunisation requirements that must be met.

- preparation of breakfasts, soups, gravies and fast serve foods (for example sausage rolls, wraps and bacon and eggs)
- cut and portion ingredients for meal packs
- receive stock, reconstitute (requiring decision on temperature and time selection) and plate frozen food
- notify food complaints to supervisor
- assist clients to fill-out menus (request for specific dietary requirements should be referred to the appropriate employee)
- service, plate and deliver food.
