### Building an inclusive, diverse and active humanitarian movement based on voluntary service

#### Role purpose

Assisting with the delivery of the Transport program under the National Disability Insurance Scheme (NDIS). Volunteers support participants by transporting them to school in the morning and afternoon, thereby helping to reduce the impact of living with a disability on participants' families and promoting social inclusion for the young person.

#### Role responsibilities

- Drive vehicle consistent with the SA Road Traffic Code. A probationary period of 4 weeks is required.
- Pick up and transport participants to school in accordance with the daily schedule.
- Adhere to transport communication processes, using mobile phones and Bluetooth where required.
- Ensure a safe, courteous and respectful transport experience for the participant and their families.
- Assist participant with lightweight mobility aids where required.
- Record and maintain vehicle safety, presentation, cleanliness and log book.
- Ensure there is no smoking or food consumed in the vehicle.
- Maintain participant confidentiality, dignity and privacy at all times.
- Report any concerns around participant safety, while maintaining privacy and confidentiality.

#### Knowledge, skills and experience

- Excellent driving record and understanding of Road Traffic Regulations
- Able to demonstrate empathy for participants with a disability and their families.
- At ease working independently or as part of a team to share the workload
- Basic admin skills and knowledge of Microsoft Office including email
- Ability to read and use maps, street directories or GPS navigation equipment and software
- Ability to understand schedules and coordinate appointments

### Check requirements

- A National Criminal History Check prior to commencement and renewed every five years (Red Cross will arrange this)
- Working with Children's Check relevant to your state / territory location
- NDIS Worker Check relevant to your state / territory location
- Reference Check

### Learning and development

- Complete Red Cross online learning modules as required
- Attend Red Cross Volunteer Induction, Program Training and ongoing training as required
- Participate in Indigenous Cultural Competency Training (Desirable)
