Purpose

Under broad direction, and at the direction of the General Counsel, to provide legal advice to the ABC on all aspects of its operations.

Key Accountabilities

Under the supervision of the Head of Disputes & Litigation, manage files across the full range of the practice of ABC Legal, with particular emphasis on complaints and litigation including:

- Preparing responses to complaints.
- Conducting factual investigations and legal research relevant to complaints and litigation.
- Preparing drafts of pleadings and other court documents (such as defences, answers to interrogatories and lists of documents).
- Instructing external counsel at court; and
- Advising on a range of media law disputes involving issues of defamation, suppression and non-publication orders, contempt of court, and intellectual property, and responding to investigations/search warrants being performed by the Police and other regulatory bodies.
- Assist with and oversee more complex projects including production of automated precedents and the identification of risk management protocols for the ABC.

- Work collaboratively with team members and support senior members with the supervision and mentoring of junior members as required.
- Maintain an up-to-date understanding of relevant legislation and caselaw.
- Actively promote the ABC values and apply all relevant workplace policies and guidelines.
- Cooperate with any reasonable instruction, procedure or policy relating to safety and take reasonable care for your own safety and that of other people who may be affected by your conduct while at work. Additional WHS responsibilities apply to Managers and Supervisors, Team Directors, and other Officers.
