Position Purpose

In providing specialist and expertise advice, this position will take a lead role within the Integrated Transport Planning team, specifically regarding the establishment and achievement of multi-modal and network principles and outcomes in consideration of regional, strategic and land use planning and development growth within the City of Moreton Bay (CMB).

Responsibilities & Outcomes

As a Lead Transport Planner and member of the Integrated Transport Planning & Design department you will:

- Lead and advise on multimodal transport investigations (and when required those specifically related to public transport) with consideration of Council's preferred outcomes regarding strategic transport and network, land use and strategic planning and private development, including but not limited to growth, investigation or priority development areas and the application of Council's Planning Scheme..
- Lead the reviews, drafting and development of planning briefs, scopes, specifications and general planning documentation and manage consultants/projects.
- Lead ITPD input on, response to, and meeting the actions of Council's corporate and strategic documents and directions, including the LGIP, Planning Scheme, the Integrated Transport Strategy (ITS), the Environment and Sustainability Strategy and Growth Management Strategy.
- Lead the development and meeting of Council's preferred Public Transport (PT) outcomes, specifically as outlined in Council's strategies, Planning Scheme and completed studies and ongoing work such as the PT Framework, PT Usage.
- Lead ITPD input and direction on any review or development of Council policy or guidelines such as e-Mobility, Integrated Transport Assessment (ITA), Planning Scheme, LGIP, Car Parking, Corridor Prioritisation and Protection, Electric and Autonomous vehicles, and Emerging Technologies.
- Be the primary and lead contact for the liaison and relationship development between ITPD and Strategic Infrastructure Planning (SIP), Strategic Planning and Place-Making (SPPM) and Growth Areas (GA), ensuring improved understanding and consistency of and between the respective work of each.
- Continue to develop and apply your demonstrated knowledge and experience of relevant state and national planning and guidelines, funding opportunities and approval processes, that are applicable to and inform ITPD planning and projects and undertake liaison with respective external agencies as and when required.
- Be the primary and lead contact for all property matters referred to ITPD that are not project related, such as general road reserve or boundary and private property adjustments that would impact the existing or planned transport network.

- Inform the currency/accuracy of Council's capital works and operational planning programs.
- Respond to Councillor and Customer requests relating to your role and employ a range of verbal, visual and written communication techniques including where necessary community consultation and other external stakeholders.
- Contribute to a positive team environment in order to achieve a high performance, continuous improvement and learning, and customer focused culture.
