The Department comprises clinical research, teaching and education, and administration personnel, as well as HDR and Honours students. The Department is well known for its innovative and cutting-edge clinical research in Women's Mental Health, translating basic science into new treatments for serious mental illness. The Department also has satellite sites at Cabrini Hospital in Malvern and at Peninsula Clinical School. POSITION PURPOSE

This position is for an Academic Psychiatrist and Level D, who is expected to make major original contributions to all activities of the organisational unit or interdisciplinary area and to play a significant role within their profession or discipline. Academics at this level may be appointed in recognition of marked distinction in their area.

This position provides academic and research leadership within the department and the incumbent will be expected to lead their own research program which should generate competitive research grants and funding, publications in peer reviewed journals and presentation of outcomes at national and international conferences and meetings. The position will also supervise postgraduate and higher degree research students. In addition, the position will provide active support to the HOD, including representation at committees and in other forums associated with the Departments strategic goals

KEY RESPONSIBILITIES

Specific duties required of an Associate Professor and Deputy Head of Department may include:

1. The conduct of independent research in which the academic may work as part of a team and the production of conference and seminar papers and publications from that research
2. Supervision of research-support and administrative staff

3. A major role in all aspects of major research projects including management and/or leadership of large research projects or teams
4. Supervision of the research of less senior research-only Academic staff
5. Promotion of research links with outside bodies
6. Preparation of research proposal submissions to external bodies
7. Responsibility for the oversight of financial management of grants
8. Involvement in professional activities including, subject to availability of funds, attendance at conferences and seminars in the field of expertise
9. Occasional contributions to the teaching program within the field of the staff member's research
10. Supervision of major honours or postgraduate research projects
11. Higher level research-related administrative functions
12. Some involvement in the development of research policy
13. Attendance at meetings associated with research or the work of the organisational unit to which the research is connected and/or departmental, school and/or faculty meetings and a major role in planning and committee work
14. Significant contribution to the discipline in which the research efforts of the academic are undertaken
15. Other duties as directed from time to time

KEY SELECTION CRITERIA

Education/Qualifications

1. The appointee will have:
 - Current registration with the Australian Medical Board and be a Fellow of the Royal Australian + New Zealand College of Psychiatrist;
 - a doctoral qualification and/or recognised significant experience in the relevant discipline area.

In determining experience relative to qualifications, regard shall be had to teaching experience, experience in research, experience outside tertiary education, creative achievement, professional contributions and/or contributions to technical achievement. In addition, a position at this level will normally require a record of demonstrable scholarly and professional achievement in the relevant discipline area.

Knowledge and Skills

2. A strong publication record in high-quality journals or equivalent and outstanding contribution to the discipline
3. Successful track record in obtaining external research grants
4. Record of successful supervision of postgraduate research students and the ability to make a significant contribution to postgraduate training programs
5. Demonstrated excellence in teaching in the relevant discipline area (i.e. through evaluations, innovation in presentation and through curriculum development)
6. Demonstrated ability to mentor staff and students
7. High level of interpersonal skills and a proven ability to establish good working relationships with colleagues, students and members of community and professional bodies

8. Demonstrated leadership in committees and other administrative work and portfolios
9. Proven ability to promote the discipline internally within the University as well as externally both nationally and internationally
10. A demonstrated capacity to work in a collegiate manner with other staff in the workplace
