ABOUT THE ROLE

Role Purpose

This role is responsible for the project management of the delivery of the refurbishment of rooms within our Ageing services and units in our Retirement & Independent Living Villages. The Uniting NSW.ACT portfolio of sites covers NSW and the ACT, with the territory divided between Sydney Central, North and South, therefore some travel is required. In all instances, the Project Manager - Refurbishments shall be responsible for (included but not limited to):

- The scoping of vacancies;
- The review of the returned quotations for agreed scope of works;
- The recommendation of the quotation for approval by the Head of Capital Works;
- The management of the delivery post approval; and
- The close out of the refurbishment project (financial administration and handover documentation).

In addition to this, the role assumes responsibility for the delivery of a limited volume of minor capital works projects in the Seniors portfolio. In this capacity, the Project Manager – Refurbishments shall be responsible for the engagement of relevant external third-party consultants (including but not limited to interior design, architecture, services engineering, PCAs and building code consultants as appropriate). The size of projects to be managed directly shall nominally be to a maximum value of \$1M however this will depend on project complexity; an external Project Manager will be engaged as agreed between the Project Manager – Refurbishments and the Head of Capital Works.

The Project Manager – Refurbishments plays a key role in managing the delivery of works via the existing Schedule of Rates contract agreement, ensuring costs align with agreed contracted costs, programmes and other key performance indicators as set under the contract. Managing non-compliance to the contract and ensuring rectification of the same form part of the role in addition to completing audits of a minimum of 10% of works completed under the Schedule of Rates Contract. The Project Manager – Refurbishments shall lead the quarterly KPI meetings held with panel contractors in their region in conjunction with the Uniting Procurement business partner, supported by the Head of Capital Works.

ROLE KEY ACCOUNTABILITIES

You will be an integral member of the Capital Works team in the Property & Housing Directorate through the following:

- Maintain a high standard of conduct and work performance based on Uniting’s values to promote our reputation with key internal and external stakeholders
- Ensure integration and collaboration across Uniting programs to deliver seamless and impactful end to end services with the customer at the centre
- Actively engage and participate in the performance management framework and review processes at Uniting
- Act in a manner which upholds and positively reflects the Uniting Code of Conduct and Ethical Behaviour
- Contribute to a culture of openness, feedback and productivity.

As the Project Manager – Refurbishments , your role specifically will:

- Act as the main point of contact for internal service recipients who identify a room or unit requiring refurbishment and for minor capital works projects to common areas as requested on an as-needs basis;
- Raise the required financial authorization document to allow the commencement of works;
- Act as the main point of contact between the external project management provider and the organization for any issues during the refurbishment programme;
- Be required to demonstrate agility and adaptability to changing delivery environments, stakeholders and external supply partners
- Ensure the timely completion of the refurbishments in accordance with agreed Service Level Agreement timeframes and relevant WHS policies, both at an Organisation and industry standard level;
- Attend handover inspections at the achievement of practical completion of the works;
- Ensure financial close out of each refurbishment is achieved within 30 days of practical completion to allow the closure of the project code associated with the refurbishment;
- Update all reporting tools in a timely manner to ensure information available is current;

- Manage key relationships with internal stakeholders including by not limited to Asset Management, WHS Business Partners, Service Managers, Village Managers, Head of Seniors Services and Area Managers;
- Attend formal monthly meetings with the relevant Asset Managers and Heads of Residential Operations and provide summary of these to the Head of Capital Works;
- Provide reports to the Head of Capital Works for works in your region including but not limited to programme and budgets. Reporting will also be required against Service Level Agreements for our Ageing and Retirement & Independent Living business streams.

- Proven experience in the delivery of commercial refurbishment projects;

- Program development, implementation and ongoing monitoring.
