The Registered Nurse provides nursing services to eligible community clients in their homes and clinic settings.

The Registered Nurse consolidates knowledge and skills and develops in capacity through continuous professional development and experience.

The Registered Nurse accepts accountability for own standards of nursing care and for activities delegated to others.
