The successful candidate will be expected to lead graduate (DMD, and DCD) students, to teach Endodontics and Dental Traumatology, and to conduct and supervise research. In line with the level of appointment, more senior responsibilities and leadership will be expected.

Show evidence of an active role in the maintenance of academic standards and in the development of educational policy and curriculum areas.

Ability to teach graduate students in a range of areas of Endodontics and Dental Traumatology.

Commitment to the supervision of graduate research students.

An interest in the development of research policy.

Demonstrate an ability to foster the research of other groups and individuals through collaboration.
