# About ANU College of Law



Since 1960, ANU College of Law has stood as a leader in legal research, addressing contemporary legal, social and political challenges in Australia and around the world. Balancing global outlook with local focus, we have a long-standing reputation for excellence in legal education, research and community outreach.

This, coupled with our role as the national university, means we have a responsibility to be ambitious, bold and transformative in our research and teaching. Our campus is located at the heart of the national capital, alongside foreign missions, the Australian Parliament, other national institutions, research organisations and government departments.

Across undergraduate, postgraduate and research degrees, we provide our students with a unique understanding of current law and policy.

As Australia's national law school, we provide national research leadership on the most important legal, regulatory and governance challenges facing Australia, the Asia-Pacific region and the world. ANU leads the nation in

research excellence, confirming our reputation as a world-class university for law and legal research by receiving the highest possible ranking in the 2018 Excellence in Research for Australia (ERA). ANU legal scholars have received a five-star rating in all four rounds of the ERA since it began in 2010. The ERA results recognise the University's continuing tradition of global excellence in legal research.

Our capital city location links us with the nation's key law-making and legislative bodies. Our researchers work closely with government departments, research agencies, NFPs/NGOs, other universities and the wider legal community to support and enhance legal education, research and policy in Australia and around the world.

## Research excellence

Recognised around the world, our research has long been known for scholarly excellence and positive impact. Since our beginning, we have attracted academics, researchers and practitioners from across Australia and abroad. Together, these scholars have engaged with governments, communities and the wider legal profession to produce world-class research, and make important contributions to the development of the law and public policy.

#### **Humanising Machine Intelligence**

Funded by the ANU Grand Challenges Scheme, the Humanising Machine Intelligence (HMI) project is an interdisciplinary, impact-driven research collaboration between computer scientists, ethicists, mathematicians, lawyers and sociologists. Among its chief investigators is ANU College of Law Associate Professor Will Bateman. The HMI project aims to harness the power of artificial intelligence while ensuring society's best qualities are protected. "The biggest challenge is ensuring public law rules, which control governance, are applied to algorithmic public service utilisation," says Dr Bateman. "I'm running a major research project explicitly focused on updating public law principles that apply to governance to ensure that people's individual rights and group rights are properly protected in the age of AI."



#### Innovative, interdisciplinary and international

With more than 30 years of history, the ANU Centre for International and Public Law enjoys a well-deserved reputation as a hub of international legal thought and debate. In 2021, three of our scholars-Professor Jeremy Farrall, Professor Jolyon Ford SFHEA and Associate Professor Imogen Saunders-were awarded \$610,700 in Australian Research Council funding for their project, 'Reconceiving Engagement with International Law in a Populist Era'. The project seeks to address the fundamental problem of how to reconceive engagement by states with the international legal order in the face of a sustained populist backlash.



#### A powerhouse for socio-legal research

In 2021, the ANU College of Law made history when three of our researchers were awarded almost \$1.3 million in Federal Government funding for their interdisciplinary, socio-legal projects under the Discovery Early Career Researcher Awards (DECRA) scheme. The awards to Associate Professor Rebecca Monson, Associate Professor Moeen Cheema and Dr Eve Lester made ANU the first Australian university to secure three DECRA grants in the Law and Legal Studies field of research in a single year.



#### Unique strengths in law and technology scholarship

The ANU College of Law is a hub for some of the Asia-Pacific region's leading scholars in the field of law and technology. From artificial intelligence and automation to robotics and rule of law, our research aims to solve real-world issues, enrich international scholarship, influence policymaking and improve the law's application of technology.



#### International partnerships and global engagement

Our research is enriched by our partnerships with universities, governments and businesses across the Asia-Pacific region. We are a proud founding member of the National Law Schools Network that also comprises the National University of Singapore, Peking University and the University of Tokyo, all members of the International Association of Research Universities (IARU) alliance. The National Law Schools Network aims to strengthen relations with partners in our region, and to share insights and ideas on shared challenges of national law schools.

Bringing together extensive experience and real-world insight, our teachers are experts both in their legal disciplines and in legal education. Our scholars engage regularly with government and the profession, producing world-class scholarship and making important contributions to the development of the law and public policy.

#### Research-led education

A number of ANU courses adopt a research-led curriculum whereby subject content is based on the specialist research interests of the teaching staff. For example, in 2020 Professor Vivien Holmes and Honorary Associate Professor Peter Burnett supervised a study by GreenLaw under the ANU Law Reform and Social Justice research and policy group. The study, an empirical review of all 32 cases under Australia's federal environment laws between 2009 to 2019, dispelled the myth of federal courts being inundated with 'lawfare' and 'green tape', finding the cases accounted for just 0.06 per cent of the Federal Court's annual caseload.

In 2021, GreenLaw students spoke before the Australian Capital Territory (ACT) Standing Committee on Environment, Climate Change and Biodiversity's Inquiry into Renewable Energy Innovation in the region. Their testimony expanded on a written submission to the Inquiry on the benefits of community-scale batteries and how to incentivise their uptake in the ACT.



# Finding my 'research home' at the ANU College of Law

Dr Jessica Hambly is a socio-legal scholar and Deputy Director of the ANU Law Reform and Social Justice (LRSJ) research and policy group. She joined the ANU College of Law as a postdoctoral fellow in February 2020.

With research interests spanning asylum law and procedure, refugee rights, gender and migration, legal geography, and other fields, Dr Hambly was drawn to the ANU College of Law by its reputation as "a top research institution with leading scholars in the field".

"I wanted a 'research home' where I could develop my own research, but also know that I'm in a network of other researchintensive scholars," she says.

As Australia's national law school, the ANU College of Law strives to shape and influence public policy with an emphasis on the values of law reform and social justice. For Dr Hambly, the opportunity to embed this ethos in her research and teaching was a huge advantage.

"When I was looking up ANU College of Law, LRSJ was one of the research groups that caught my eye. It was a real standout to see this as an initiative and reflect the College's own commitment to social justice," she says of the group, which has a dozen student-led projects related to Indigenous reconciliation, climate justice, refugees, rule of law and more.

"A lot of my research is socio-legal and related to the courts, so to have these institutions—from the ACT Supreme Court to the High Court of Australia—literally on our doorstep is really exciting."



Dr Hambly was then appointed as a Senior Lecturer in October 2021, sealing a memorable experience as a postdoctoral fellow shaped by significant research outputs.

"The opportunities were there to progress my career. It was really nice to be trusted with things quite early on, from projects that align with my expertise and research interests to other things that challenged me," she says.

The opportunities for transdisciplinary work at ANU—home to seven academic colleges and dozens of schools—have also paved the way for meaningful scholarly collaborative experiences, says Dr Hambly.

"You could be any legal scholar and find someone outside of law who is doing similar research to you," she explains.

"Early on, I was involved in NECTAR (The Network for Early Career Academics at ANU). It gave me the opportunity to meet other early career scholars from across ANU."

Originally from the United Kingdom, Dr Hambly admits life in the 'bush capital' won her over soon after arriving with its abundance of accessible green space, picturesque natural environment and rich bushland settings.

"The city itself was a massive attraction," she says.

"I love living in Canberra because you have political and cultural institutions, the lake (Lake Burley Griffin), mountains and just a really high standard of living. It lends itself to an excellent work-life balance."

#### Purpose statement

Responsible to:

A Postdoctoral Fellow (Academic Level B) is expected to carry out independent research within the field in which they are appointed and to carry out activities to develop their research expertise relevant to the particular field of research. The core purpose of all the positions on academic staff is to make a contribution to advancing the discipline of law by: a) exploring the boundaries of legal knowledge through research, scholarship, and the dissemination of scholarship; b) educating future lawyers and associated professionals to be competent, ethical, and act in the service of society; c) sharing and spreading the benefit of legal knowledge and skills amongst wider audiences by engaging in appropriate outreach activities; and d) infusing all of these activities with an interest in underlying questions of law reform and/or social justice.

#### Position dimension and relationships

Two-year appointment: Prepare a variety of high quality published outputs, for example, through monographs, peer-reviewed articles or edited volumes. Outputs must be returnable in the 'Excellence in Research Australia (ERA)', Field of Research (FoR) for #18 (legal studies). Undertake a small teaching commitment in the second year of the appointment, which will be designed to deliver an experience of the Higher Education environment.

**Three-year appointment:** Develop either a new research project or a research project that demonstrates a significant development of the subject of the Post Doctoral Fellow's doctorate. This will be done through a variety of appropriate, feasible and clear published outputs, which must be returnable in the ERA FoR 18 (i.e. legal studies). Seek Australian Research Council (ARC) or similar funding and receive mentoring to achieve this. Undertake a small teaching commitment in years two and three of the appointment, which will be designed to deliver experience of the Higher Education environment.

#### Role statement

Specific duties required of a Post Doctoral Fellow (Academic Level B) may include:

- The conduct of research either as a member of a team or independently, and the production of publications from that research.
- Involvement in professional activities including, subject to availability of funds, attendance at conferences and seminars in the field of expertise.
- Apply to funding bodies to enable efficient progression of the research plan.
- Administrative functions primarily connected with his/her area of research.

- A small fractional contribution to the LLB or LLM teaching ogram within the field of the staff member's research.
- Co-supervision, or where appropriate supervision, of major honours or postgraduate research projects within the field of the staff member's area of research.
- Attendance at meetings associated with research or the work of the organisational unit to which the research is connected and/or departmental and/or faculty meetings and/or membership of a limited number of committees.
- Compliance with all ANU policies and procedures, including those relating to work health and safety and equal opportunity.
- Other duties as allocated by the supervisor or the Vice-Chancellor consistent with the classification of the position.

#### Skill base

Applicants are required to have been awarded their PhD and to have authored at least one peer reviewed publication during their PhD or since its award. This publication cannot be a book review, a review article, a piece in refereed conference proceedings or a submission in a student journal. A contribution to an edited collection is acceptable provided that evidence of peer review can be supplied.

#### Selection criteria

- LLB with honours (or equivalent) and a PhD in law or a cognate discipline awarded within the last 12 months.
- Demonstrated research skills with a clear future research agenda and awareness of how your research agenda compliments research currently being undertaken at the ANU College of Law and the wider ANU.
- Awareness of the impact of research agenda as currently defined by the Australian Research Council (ARC).
- Demonstrated ability to undertake high quality original research and scholarship and, for a three year appointment, an ability and interest in obtaining external research funding from the ARC or other appropriate funders to support individual and collaborative research activities.
- Demonstrated ability to publish research findings in high quality publication outlets.
- Demonstrated ability to deliver effective teaching and course administration.
- Ability to undertake outreach activities in line with the interests of the College.
- Demonstrated effective interpersonal skills both verbal and written. including the ability to prepare grant applications, reports and present results to a range of audiences, and an ability to liaise effectively with a wide range of people in a culturally diverse environment.

#### **History**
