## 1. Position purpose

This position sits within Therapeutic Services, is funded through Department of Families, Fairness and Housing (DFFH)/Family Safety Victoria (FSV), and will be responsible for delivering short to medium term family violence therapeutic interventions to children and young people residing in a family violence refuge with their family as well as children and young people affected by family violence in the community.

The purpose of the Therapeutic Specialist position is to:

- Promote and facilitate safe, stable and nurturing environments for vulnerable children and families in our communities.
- Make a positive contribution to children's adjustment and development by designing and implementing tailored therapeutic interventions for vulnerable children and their families; and
- Provide professionals and community stakeholders with professional development opportunities that promote the most effective approaches and contemporary knowledge in working with vulnerable children and families.



Therapeutic Specialist – Family Violence (Psychologist, Social Worker, Counsellor)

Primarily based at Dandenong and Doveton, the Therapeutic Specialist will also be required to travel to complete clinical tasks such as attending case conferences, and conducting home and school-based services.

## 4. Key responsibility areas

# Service delivery

- Support and educate carers/parents to increase their understanding of the child/young persons' experience of trauma, with the aim being to increase the child/young person's social, emotional, behavioural and developmental functioning.
- Provide preliminary therapeutic supports/interventions to children/young people and their carer/parent during their episode of care within the refuge.
- Provide carers individualised education regarding the child and their presentation/behaviour.
- Observe the child/young person and their interactions with their carer/parent within the refuge.
- Provide a therapeutic space for parent and child to be able to safely connect and positively bond.
- Contribute to case plan and professional meetings as negotiated.
- Liaise with relevant professionals, and provide education and support to the child's network, to create a plan for the families continued healing journey, help support relevant professionals to make appropriate referrals and plan for future relevant trauma informed therapeutic services.

## **Duties and Responsibilities**

- Provide specialist consultation to case managers, parents/carers, client families and other professionals
- Facilitate and participate in a reflective learning environment within the organisation
- Develop and maintain skills and ethical practice to a high level according to best contemporary practice
- Manage the development and delivery of specific portfolio projects
- Manage the development and co-ordination of groups for families, children & young people
- Maintain privacy and confidentiality as per organisational policy
- Maintain data systems including timely collection, uploading and reporting
- Actively mentor students / interns and other staff

- Maintain professional conduct and ethical practice in accordance with the Code of Ethics of relevant professional society and Uniting policies
- Other projects and duties, as required

#### Administration

## 5. Person specification

#### Qualifications

- The minimum qualification for this role is a Bachelor of Social Work or equivalent qualification
- OR a minimum of 5 years relevant professional experience or a related qualification relevant to child and family welfare as per the mandatory minimum qualifications for family violence practitioners
- OR significant cultural knowledge and experience or lived experience, and have faced barriers to educational pathways as per the mandatory minimum qualifications for family violence practitioners
- Current Victorian Driver's Licence

## **Experience**

- Substantial experience providing assessments, therapy / counselling services to children, adults, couples and families with complex needs. This would mean that you have completed counselling with complex clients.
- Substantial experience providing therapeutic support to families that have experienced trauma/ family violence.
- Demonstrated understanding of the gendered nature of family violence, and feminist theory in responding to violence against women and children in the home.
- Demonstrated knowledge of relevant theoretical approaches for working with children, adults, couples and families.
- A clear understanding of the issues facing families, children and young people who have experienced trauma and/or attachment difficulties
- Some experience providing parenting assessment, strategies, and education to carers and parents of vulnerable children with challenging behaviours
- Shows awareness and understanding of child abuse and neglect
- Demonstrated knowledge of practices to engage and assure the cultural safety of clients from a diverse range of backgrounds, including those from an Aboriginal, Torres Strait Islander or Culturally and Linguistically Diverse (CALD) background, or the LGBTIQ+ community
- Working knowledge of the Multi-Agency Risk Assessment and Management (MARAM) framework
- Experience providing crisis therapeutic support and/or short-term therapeutic interventions.
- Demonstrated competence in providing psychological therapies and services to children, young people, parents and carers with diverse and/or complex needs.
- Demonstrated competence in applying relevant theoretical approaches in planning and implementing therapeutic interventions, formulations and assessments.
- Demonstrated competence in assessment of children, adults and families, including emotional, developmental, cognitive, and systemic considerations.
- Experience providing play therapy/art therapy/dyadic therapy/trauma therapy/sensory-motor therapy to children and young people- Desirable.
- Experience in providing clinical supervision and mentoring to staff and/or students-Desirable
- Experience providing family and/or couple relationship counselling Desirable.
- Experience facilitating psycho-therapeutic groups Desirable.

#### **Core selection criteria**

- Values alignment: ability to demonstrate and authentically promote Uniting's values.
- **Child Safety:** demonstrated ability to provide safe environments for children and young people and protect them from abuse and neglect.
- **Risk management:** demonstrated competence in assessing risk and responding appropriately
- **Organisational skills:** strong ability to multitask and prioritise work commitments, able to manage multiple priorities
- **Communication:** open, honest, articulate and flexible approach to communication written and verbal, and ability to actively listen.
- **Administrative skills:** confident user of Microsoft office and Outlook, demonstrated competence in report writing and case file notes to a high standard.
- **Interpersonal focus:** strong interest in people and respect for others. The ability to suspend judgement.
- **Cooperative:** demonstrates team behaviours striving for co-operative and professional relationships.
- **Conscientious:** Responsible, dependable, organised and persistent.
- **Open to experience:** High level self-awareness, with the ability to recognise mistakes, as an opportunity for reflection, learning and development.
- **Professionalism:** professional, confident, focused and clear about purpose and able to set appropriate personal boundaries.
