### **ABOUT THE ROLE**

#### Role Purpose

This role is responsible for contributing to the development of the Permanency Support Program (PSP) carer engagement and support, within current and transformational sector permanency and restoration reforms. This role is key in engaging, enlivening and supporting Uniting's PSP carers and support services for carers. Members of the Uniting team in this role will relate to carers in the PSP framework with strong messages about restoration, connection with family and short term placement principles. This role will enable carer capability by enabling networking, training and connecting carers with the Uniting team and child focused principles.

### **ROLE KEY ACCOUNTABILITIES**

- Works consistently and keeping with WH&S behaviours and actions within the team and department, and ensure there is a safe working environment and that staff are properly trained to be able to work in a safe manner.
- Use industry best practice to facilitate and co-ordinate support group activities connecting carers.
- Works closely with the Coordinator and the casework team to provide best practice support for foster carers.



- Provide informal and formal therapeutic interventions for groups and individuals to support foster carers and the creation of foster carer networks.
- Demonstrate respect for the rights, values, customs, spiritual beliefs and practices of individuals and ensure these needs are met.
- Apply the Aboriginal service delivery principles as appropriate.
- Takes responsibility for high quality service provision.
- Works collaboratively and flexibly with external experts and Uniting colleagues to accredit carers.

As the Carer Engagement Support consultant PSP, your role specifically will:

- Builds strong links with carers and between carers enabling carer support and support networks.
- Produce the highest quality re-assessments, assessments reports (as required) and annual reviews proactively linking carers education and training options to improve their skills.
- Accept, manage and register (Carelink) carer inquiries to welcome people interested in becoming carers.
- Support carers through transitions (first placements, types of placement, entry and exit) via tailored plans or finishing as a carer through exit interviews and acknowledgement as appropriate.
- Provide information and training on the carer role to potential foster carers including Shared Lives training.
- Facilitation of discussion groups to support carers, provide information and enable them to share experience and skills.
- Assist carers through challenging periods (including investigations) providing counselling and support or joint support with the casework team when appropriate. (This may include Lifestory work with the Child or Young person).
- Coordinating and organising recognition and celebration activities for carers.
- Taking the primary responsibility for matching placements with carers.
- Meet compliance requirements for PSP support services including maintenance of necessary assessment data entry on the carer register.
- Oversee and participate in the PSP After Hours Emergency roster so that all duty of care requirements for children, young people and carers.
- Participate in (as directed) agency wide responses to PSP sector initiatives, policy and legislative development with FACS, ACWA and other relevant government or nongovernment organisations.
- Work collaboratively with Uniting's marketing and 1800 team to manage carer inquiries proactively.
- Work flexibly within your team as required to cover all aspects of carer support.
- Contribute to the implementation of Uniting's quality management system including policies, processes, systems and platforms (including technology) so as to ensure best practice and efficiency of the Carer Support team.
