Educational/Vocational Qualifications:

- > Registered or eligible for registration as an enrolled Nurse with the Nursing and Midwifery Board of Australia and who holds, or who is eligible to hold, a current practicing certificate
- > In order to administer medicines, must have completed an approved program of study which includes an administration of medicine.

Personal Abilities/Aptitudes/Skills:

- > Effective verbal and written communication skills
- > Ability to work in a multidisciplinary team environment
- > Ability to prioritise workload, recognise and report changes in clinical condition
- > Ability to provide person-centred care

Experience:

> Experience in the provision of nursing care in the healthcare setting in accordance with the appropriate standards of practice.

Knowledge:

- > Knowledge and understanding the role of the Enrolled Nurse within the health care setting.
- > Knowledge and understanding of relevant legislation, industrial agreements, standards, codes, ethics and competency standards.

- > Intravenous Cannulation Accreditation preferred but not essential

Personal Abilities/Aptitudes/Skills:

Experience:

> Experience in quality improvement activities (e.g. the development and/or implementation of clinical standards, practice guidelines, protocols/audits and guality indicators)

Knowledge:

- > Knowledge of contemporary professional nursing/midwifery issues
- > Knowledge of the South Australian Public Health System.

Special Conditions:

- It is mandatory that no person, whether or not already working in SA Health, may be appointed to a position in SA Health unless they have provided the a satisfactory current Criminal and Relevant History Screening, as required by the SA Health Criminal and Relevant History Screening Policy Directive.
- > For appointment in a Prescribed Position under the Child Safety (Prohibited Persons) Act (2016), a current Working with Children Check (WWCC) is required from the Department for Human Services Screening Unit. For other positions, a satisfactory National Police Certificate (NPC) assessment is required.
- > For 'Prescribed Positions' under the Child Safety (Prohibited Persons) Act (2016), the individual's WWCCs must be renewed every 5 years from the date of issue; and for 'Approved Aged Care Provider Positions' every 3 years from date of issue as required by the Accountability Principles 2014 issued pursuant to the Aged Care Act 1997 (Cth).
- > Appointment is subject to immunisation risk category requirements. There may be ongoing immunisation requirements that must be met.
- > Depending on work requirements the incumbent may be transferred to other locations across SA Health to perform work appropriate to classification, skills and capabilities either on a permanent or temporary basis subject to relevant provisions of the *Public Sector Act 2009* for Public Sector employees or the *SA Health (Health Care Act) Human Resources Manual* for Health Care Act employees.
- > The incumbent may be required to participate in Counter Disaster activities including attendance, as required, at training programs and exercises to develop the necessary skills required to participate in responses in the event of a disaster and/or major incident.
