Service Information

COMPASS is a leaving care initiative between Anglicare Victoria and Vincent Care and is Australia's largest Social Impact Bond. COMPASS will help young people successfully transition from Out of Home Care and set them on a positive path to independence. The COMPASS Model

1. Step-up, step-down' housing – a flexible housing model that will allow young people to engage with different housing options depending on their individual circumstances. Young people will have the option to receive support to continue to live with their current foster or kinship carer, or be supported to transition into independent housing through supported rental arrangements or spot purchases.
2. Individualised tailored support – A key worker will work alongside the young person to support their aspirations and goals and will ensure they have the skills and supports required for independent living. The key worker will be able to access general and specialist supports in the community. A tenancy worker will also support the young person to find and secure long term accommodation.

COMPASS is an evidence based program that will be formally and independently evaluated to determine if the model has been able to improve the experience of care leaves and set them on a positive path to adulthood. The evaluation will measure young people's progress for a total of 4 years, 2 years while they are engaged with COMPASS and 2 years post COMPASS support.

COMPASS will be measured on three outcomes and investors will get a return on the success of these outcomes

1. Achievement of stable housing – a decrease in homelessness as measured by access to short-term or emergency accommodation from Specialist Homelessness Services.
2. Improved health – physical and mental health improvements as measured by emergency department presentations
3. Decrease in offending behaviour – as measured by the number of convictions recorded.

Position Objectives

- Provide assertive outreach support and case work to young people who are transitioning from Out of Home Care to Independent living. Young people will either be living independently in a housing option or being supported to continue to reside with their Foster or Kinship Carer.
- Establish a rapport with the young person, understand their aspirations and work together to set and achieve their life goals.
- Assist young people in attaining education, employment and training opportunities which will ensure they are working towards being financially self-sufficient.
- Ensure that young people are familiar and connected with their primary services in order to be able to live independently beyond their involvement with Compass.
- Engage families where appropriate to ensure young people have the opportunity to reconnect, reunify and understand their family history and maintain connections into the future.
- Be a role model and demonstrate positive attributes that allow young people to learn and feel safe which reduces their vulnerability, builds resilience and encourages aspirations for their future.

Key responsibilities

| 6. | Maintain administrative and documentation requirements in accordance with Anglicare Victoria and Compass program guidelines. |

Key Selection Criteria

Applicants are required to provide a written response to the role specific requirements. The five criteria are to be addressed individually (no more than 2 pages in total).
