POSITION PURPOSE

The aim of the Monash-Epworth Rehabilitation Research Centre (MERRC) is to conduct ethical, innovative and internationally competitive research investigating outcomes and the effectiveness of intervention programs for individuals with brain injury or orthopaedic injury sustained as a result of trauma, with the ultimate aim of maximising their functional, psychological and social outcomes.

The Research Officer provides a variety of high-quality research services to support the operations of MERRC, the longitudinal head injury outcome study and other ongoing research projects. The key components of the work will involve clinical interview, cognitive assessment, and follow-up of patients with head injury and data entry. Writing grant applications, conducting literature reviews and completing other research administrative tasks will also form part of the role. The successful applicant would be required to directly report to the centre director.

The Research Officer operates with a focus on excellence in process and judgment and provision of sound and timely advice and support to other members of MERRC, participants and associated stakeholders.

KEY RESPONSIBILITIES

- Support the achievement of research outcomes by undertaking a range of research and administrative support tasks including scheduling bookings, administering questionnaires, conducting neuropsychological assessments, data collection, input and analysis and preparing results in accordance with established research objectives, timeframes and protocols
- **2.** Keep abreast of developments, activities and protocols in area of expertise through liaison with staff and peers, reading relevant literature and attending meetings and seminars
- **3.** Assist in preparing reports and other documentation, including grant applications, undertaking literature reviews and data analysis
- 4. Comply with established research methodology, policy, protocols, OHS and regulatory requirements
- **5.** Participate in and implement continuous improvement activities relating to project, research or technical procedures and quality assurance standards
- **6.** Maintain open and effective channels of communication with colleagues, research collaborators and other stakeholders to support and facilitate research objectives
- **7.** Assist in follow-up of head injured patients both over the telephone and in person at MERRC or in the participant's home
- 8. Other duties as directed from time to time

KEY SELECTION CRITERIA

Education/Qualifications

- 1. The appointee will have:
 - A tertiary qualification in a relevant field and substantial relevant skills and work experience; or
 - an equivalent combination of relevant experience and/or education/training

Knowledge and Skills

- 2. Sound analytical, technical and data analysis skills and a demonstrated capacity to apply effective technical methods, processes and systems
- **3.** Strong organisational skills, including the ability to set priorities, manage time and plan work to meet deadlines
- **4.** Demonstrated project administration skills with the ability to support research projects in accordance with agreed standards and timeframes
- 5. Ability to work as an effective member of a team as well as independently under general supervision
- **6.** Strong attention to detail and accuracy and an understanding of confidentiality, privacy and information handling principles
- 7. Well-developed communication skills, including the ability to draft a range of documentation
- **8.** A high level of computer literacy, including demonstrated experience in learning and adopting new software packages as required
- 9. Demonstrated experience administering neuropsychological tests for the brain injury population
- 10. Demonstrated experience in writing and submitting grant applications
